1. The appointee shall be on probation for a period of 02 (two) years as per APHS rule-2000 section 10(1) from the date of joining. Appointment will be confirmed only after satisfactory completion of the probation period.

No. POL-67/65 VOL -V (Pt.).— In exercise of powers conferred by Regulation 2 of Bengal Eastern Frontier Regulation (BEFR), 1873, (Regulation 5 of 1873), and in supersession of the earlier orders issued in this regard, except as respect things done or omitted to be done before such supersession, the Government of Arunachal Pradesh is pleased to introduce Tourist eLP (Version 3.0) in the State of Arunachal Pradesh, to regulate the procedure of obtaining eLP by tourists, as under :-

1. The introduction of eLP (Version 3.0) shall be purely to facilitate hassle free and easy access for obtaining eLP by tourists for travelling in the State of Arunachal Pradesh with the same term (s) and condition(s) laid down in the said Regulation.
2. The eLP (Version 3.0) portal shall be managed and controlled by the Department of Information Technology and Communication, Government of Arunachal Pradesh in collaboration with NSDL.
3. The revised fee for Tourist eLP shall be as below :-
  - (i) Up to 3 (three) days ₹ 300
  - (ii) Beyond 3 (three) days up to 14 (fourteen) days ₹ 500
4. Consequent upon the introduction of new eLP (Version 3.0), the issuances of online tourist eLP through (earlier Version) or offline mode, hitherto in operation in the State shall be discontinued forthwith.
5. The Government shall review the eLP (Version 3.0) from time to time as may be deemed expedient.

This order shall be deemed to have come into force with effect from 17th November, 2022.

No. DTC-14014/13/2022/2807-2887.— In the interest of public service, the Governor of Arunachal Pradesh is pleased to order for partial modifications of the existing guidelines for issue of Trade License, vide Notification No. DTC/TL-75/2006/559-632 dated 29th July, 2009 which are as under :-

1. Under Clause 1.4 of the said Notification, the ceiling limit prescribed for concerned DC/ADC to issue Trade License has been enhanced from ₹ 10.00 Lakhs to ₹ 50.00 Lakhs.
2. Now the Trade License can be transferable to immediate family members by executing a Gift Deed before a Judicial Magistrate.
3. Vide Notification No. DTC/TL-20/99-2000 dated 16th July, 2009 the Director of Trade and Commerce was authorized to issue/renew of Trade License for Scrap/Salvaged Materials. Now, it has been decentralized to concerned DC/ADC who will issue/renew the Trade License for Scrap/Salvaged materials.
4. For obtaining Trade License, the earlier practice of submitting all required documents/NoC by the applicants has been done away. Now, it has been decided that the Trade License can be issued on the submission of the following documents only :-
  - (a) APST Certificate
  - (b) Aadhaar/Election/Pan Card.
  - (c) Other required documents may be accepted on the basis of Self Certificate furnished by the applicant to the effect that the said document is available with the applicant and can be produced on demand and in the event of false declaration, legal action as per rules, can be initiated against the applicant.
5. The validity period of Trade License has been raised from 1 (one) year to 3 (three) years.

This supersedes all earlier order.

This order shall be effective from the date of issue of this order.
