SYLLABUS FOR JUNIOR ENGINEER (POWER)

1. General ability test:

Part A: General English - The question paper in general English will be designed to the candidate's understanding of English and workman like use of work - level senior secondary (10+2).

Part B: General Knowledge - The paper in general studies will include knowledge of current events and of such matter as of everyday observation and experience in their scientific aspect as may be expected of an educated person. The paper will also include question on history of India and geography of a nature which candidates should be able to answer without special study.

Virtual work. Motion of projectile. Uniform circular motion. Combined motion of rotation and translation, central force motion, motion of satellite, unbalance in rotating masses. Power transmission through shaft, belt and gear drives.
