### **Guidelines for grant of financial assistance to the Arunachal Pradesh Schedule Tribe (APST) youth for pursuing “COMMERCIAL PILOT LICENCE COURSE (CPL)”**

The Government of Arunachal Pradesh, Department of Higher and Technical Education is to extend financial assistance to the bonafide and deserving Arunachal Pradesh schedule Tribe (APST) youth for pursuing and obtaining “**COMMERCIAL PILOT LICENCE COURSE (CPL)**” from approved Institutions by **Directorate General of Civil Aviation (DGCA)**, Government of India for Commercial Aircraft only on a case-to-case basis.

Following guidelines/criteria will be followed for considering financial assistance to the APST student for pursuing **Commercial Pilot Training Course** is follows :

- Short titles** : This scheme may be called grant of “**Financial Assistance to the Arunachal Pradesh Scheduled tribe Youth for pursuing and obtaining “Commercial Pilot Licence Course”**”.
- Applicability** : This scheme will be applicable to the bonafide Arunachal Pradesh Schedule Tribes students for pursuing and obtaining **Commercial Pilot Licence Course** from the Government Institutions approved by **Directorate General of Civil Aviation (DGCA)** Government of India.
- Objective of the Scheme** : The Government of Arunachal Pradesh desires to encourage and provide opportunity to deserving APST students pursuing and obtaining **Commercial Pilot Licence Course**. The financial assistance shall be extended to the meritorious students admitted in such Commercial Pilot Training Institutions approved by **Directorate General of Civil Aviation (DGCA)** **Government of India**.
- Commencement** : The guidelines/Norms shall be effective from the date issue of the notification.
- Academic Course/Programme** : The scheme shall be applicable only for **Commercial Pilot Licence Course** for Commercial Pilot Licensing (CPL) only. An intending deserving student(s) shall bear the burden to ensure that such courses/programme opt is recognized/approved by Indian Government or Statutory Bodies of India like **Indira Gandhi Rashtriya Udan Academy** and any other Government institutions.
- Terms and conditions of the Scheme** :
  - Only the bonafide APST candidate(s)/youth of Arunachal Pradesh shall be eligible to apply the scheme. **Only maximum of 10 (ten)** youth shall be extended financial assistance in each financial year.

- (b) It shall be given to those selected candidate who have made through Entrance Test or undergone selection Test/course as prescribed under Directorate General of Civil Aviation (DGCA) and Ministry of Civil aviation Government of India from time to time.
- (c) The selected candidates shall be extended financial assistance not **exceeding 75%** of total training and associated fees only once for an academic year or course for obtaining **Commercial Pilot Licence (CPL)** course duration not exceeding **24 months (Two years)**.
- (d) The eligible applicant shall submit duly filled in application form in prescribed format collected from the office of Directorate of Higher and Technical Education (DHTE) or download from official website : **apdhte.nic.in** of the Directorate within the prescribed time with requisite documents mentioned in application form.
- (e) The amount shall be transferred to the students concerned bank account directly through Treasury/ PFMS mode as and when fund is made available. Bank draft or cash payment shall not be made in any circumstances.
- (f) All other expenses shall have to be borne by candidate except as mentioned in sub clause **6 (c)** above.
- (g) The candidate must furnish the mark sheet and result of qualifying examinations along with all other requisite documents. The student having year gap/academic arrear etc shall not be eligible for grant of financial assistance under the scheme. In such case, candidate has to bear the cost(s) so required.
- (h) The candidate should mention the details of Institute (**where admission has been taken**) in the application form and to submit the copy of proof of institutions bearing or indicating its recognition status.
- (i) The application must be accompanied with self-attested copies of (i) **Passport size** photographs 2 Nos. (ii) **Schedule Tribes Certificate** issued by the competent authority (iii) **Admission receipt** (iv) **Total course fee** per annum etc. (v) **Total tuition fee per annum** along associate fees if any and ; (iv) Other relevant documents.
- (j) Applicant is required to mandatorily submit **DGCA Computer Number (Unique Identification Number issued by DGCA)** for proving aviation credentials and air worthiness of Pilots and Aviation Professionals.
- (k) The candidate already in Government regular service shall not be entitled to avail this financial assistance.
- (l) Intending candidates have to submit character certificate, medical fitness certificate, etc. issued by the competent authority.
- (m) Expenditure shall be made against the fund provision under stipend/scholarship Head.
- (n) Incomplete application shall be summarily rejected.
- (o) Student shall submit copies of the certificates of qualification/degree acquired upon completion of the course including mid-term training completion certificate(s).
- (p) Any application or proposal which is not in conformity with this guideline shall not be considered or processed
- (q) The candidate shall have to complete the training course/programme once financial assistance is granted. In case of non-completion, such students shall have to repay the whole amount with interest as may be fixed by the competent authority/State Government.
- (r) If any student obtained the financial benefits by indulging in fraudulent means. He/She shall be liable for action as per the provision of law of the land.
- (s) Extending of finance assistance is subject to availability of fund provision.
- (t) Candidates has to take responsibilities of the veracity of authenticity of training institutions where he/she is studying or intending to take admission in view of fraud /fake selection or fraudulent case, student(s) have to re-fund the full amount with interest so fixed by the competent authority, if financial assistance has already been extended.
7. **The expenditure shall be charged under Scholarship head subject to the provision of fund.**
8. **The Department reserves the right to cancel or withdraw any such financial assistance already granted to a candidate under the scheme.**
9. **The Continuation of the Scheme shall be subject to review after 5 (five) Years by the State Government.**

1. **Short title and commencement** : (i) These rules may be called “**The Assistant Professor Nursing Schools/Colleges, Recruitment Rules, 2024**”  
(ii) They shall come into force on the date of their publication in Arunachal Pradesh Gazette.
2. **These rules shall apply to the posts as specified in column 1 of the Schedule Annexed to the Rules.**
3. **Number of posts, classification and Level in the Pay Matrix** : The number of posts, their classification and the Pay Band and Level in the Pay matrix attached thereto shall be as specified in columns 2 to 4 in the Schedule aforesaid.
4. **Method of recruitment, age limit and other qualifications etc** : The method of recruitment to the said post, age limit, educational qualifications and other matter relating thereto, shall be as specified in columns 5 to 13 of the Schedule aforesaid.
5. **Disqualification : No person**
  - (a) who has entered into or contracted a marriage with a person having spouse living, or
  - (b) who having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said posts. Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing exempt any person from the operations of this rules.
6. **Power to relax** : Where the Governor of Arunachal Pradesh is of the opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing and observing the procedures as prescribed under OM No. AR-89 March, 2013 and in consultation with the Commissioner relax any of the Provisions of these rules. With respect to any class or category of persons.
7. **Repeal and Saving** : All rules and procedure corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the corresponding provisions of these rules.

Nothing in these rules shall affect reservation/ relaxation of age limit and other concessions required to be provided for the Arunachal Pradesh Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.
