Terms and Conditions :

- (1) The appointee shall be on “probation” for a period of 3 (three) years as per APHS Rules, 2000 amended vide Government notification No. HFW-40/2012 part II dated 6th April, 2013 from the date of their joining. Appointment will be confirmed only after satisfactory completion of the probation period.
- (2) The appointee should report for duty at his/her respective place of posting within one month from the date of issue of this order, failing which it will be presumed that he/she is not willing to join the post and accordingly the appointment will stand cancelled.
- (3) The appointee shall serve in rural areas compulsorily for a minimum period of 5 (five) years in any part of Arunachal Pradesh, during the initial part of their service as per Government order.
- (4) If any declaration given on information furnished by the candidate if found to be false or if the candidate is found to have willfully suppressed any material fact/information, he/she will be liable to be removed/ discharge from services and such other action as Government may deem fit and proper.
- (5) The appointee may be terminated at any time by one month notice given by either side viz. the appointee or the appointment authority, without assigning any reason. The appointing authority shall however reserves the right to terminate the service of the appointee forthwith or before the notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- (6) Appointment is subject to production of certificate of fitness from the Medical Board appointed/ authorized by the Government of Arunachal Pradesh.
