**Sub : Procedure to be followed for issue of 'Last Pay Certificate' in respect of Officers/Officials on their transfer out from Itanagar Capital Complex.**

No. PERS-21011/1/2025/363.— It has come to notice that several Government employees are retaining their quarters even after being transferred from the Itanagar Capital Complex (ICC) without notifying the Directorate of Housing, which is in violation of the applicable rules and procedures.

In light of the growing concerns regarding encroachment and demolitions of Government quarters in the ICC, it is hereby directed that all Heads of Departments, Heads of Offices and Drawing and Disbursing Officers within the ICC will NOT issue 'Last Pay Certificate (LPC)' to any Government employee on his/her transfer out of the region without obtaining a 'No Objection Certificate' (NOC) from the Directorate of Housing.

Prior to issuance of NOC, the Directorate of Housing shall verify the aspects of allotment of the quarter, checking of the inventory of furniture and other items and will ensure that the keys of the quarter/flat have been returned by the transferred employee.

All concerned authorities are instructed to adhere strictly to these guidelines.
