#### **NOTIFICATION**

#### The 21st December, 2022

No.LA/Estt-14/2022.—In exercise of the powers conferred by Clause (3) of Article 187 of the Constitution of India, the Governor of Arunachal Pradesh after consultation with the Speaker of the Legislative Assembly of Arunachal Pradesh is hereby pleased to make the following rules to regulate the method of recruitment to the post of **Chief Marshal**, Group 'B' (Gazetted) Legislative Assembly Secretariat;

- 1. Short title and commencement
- (i) These rules may be called "Arunachal Pradesh Legislative Assembly Group 'B' (Gazetted) Recruitment Rules, 2022 for the post of Chief Marshal".
- (ii) They shall come into force with immediate effect.
- (iii) They shall apply to the post as specified in column-1 of the Schedule annexed to this rule.
- 2. Number of post, classification & Scale of Pay

The number of posts, their classification and the scale of pay attachéd there to shall be specified in columns 2 to 4 in the schedule aforesaid.

3. Method of recruitment, Age limit & other Qualifications etc.

The method of recruitment to the said posts, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the aforesaid schedule.

4. Disqualifications:

No person -

- (i) who has entered into or contracted a marriage with a person having a spouse living; or
- (ii) who having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts.

Provided that the Governor of Arunachal Pradesh may if satisfied that such marriage is permissible under the personal law applicable to such person and that there are other grounds for so doing exempt any person from the operation of these rules.

5. **Power to relax** 

Where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may, after consultation with the Speaker of the Legislative Assembly of Arunachal Pradesh, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving

Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to be provided for the Scheduled Castes and the Scheduled Tribes and other special categories of person in accordance with the order issued by Government of Arunachal Pradesh and as adopted by the Speaker in relation to the Legislature Secretariat in terms of Para 6 of the Notification No.LA/Estt-13/87 (1) dated 14th June, 1990, if any, from time to time in this regard.

### **NOTIFICATION**

#### The 5th January, 2023

No. AR-23016/3/2022.—In exercise of the powers conferred by Article 318 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following Regulation further to amend the Arunachal Pradesh Public Service Commission Regulations, 1988, namely:

- 1. **Short title and commencement**: (1) These Regulations may be called the Arunachal Pradesh Public Service Commission (Amendment) Regulations, 2022.
  - (2) They shall be deemed to have been come to effect from 31st October, 2022.
- 2. **Amendment to the Regulation**: In the Arunachal Pradesh Public Service Commission Regulation, 1988,
  - (i) In Part VI Regulation 18, for the existing entries the following entries, shall be substituted:-
    - "All Group A, B & C, Ministerial and Non-Ministerial (Gazetted and Non-Gazetted) staff shall be posted by the State Government from the respective Cadre of Arunachal Pradesh Civil Secretariat from time to time".
  - (ii) In Part VI Regulation 19, for the existing entries, the following entries shall be substituted:-

"Disciplinary proceedings against the officers, officials and other staff posted in the Arunachal Pradesh Public Service Commission from the Arunachal Pradesh Civil Secretariat shall be initiated by the respective Cadre Controlling Authority as per rules either directly or on the recommendations/reporting by the Commission".
