## THE ARUNACHAL PRADESH APPROPRIATION (VOTE ON ACCOUNT) (NO. 2) BILL, 2024

## BILL

*to authorise payment and appropriation of certain sums from and out of the consolidated fund of the State of Arunachal Pradesh for the services of a part of the financial year 2024-2025.*

BE it enacted by the Legislative Assembly of Arunachal Pradesh in the Seventy fifth Year of the Republic of India as follows :-

| 1. (1) This Act may be called the Arunachal Pradesh Appropriation (Vote on Account) (No. 2) Act, 2024 .   | Short title.  |
| (2) It shall be deemed to have come into force with effect from 1st April, 2024 and same shall be in force for 4 (four) months with effect from 1st April to 31st July, 2024.   |   |
| 2. From and out of the Consolidated Fund of the State of Arunachal Pradesh there may be withdrawn sums not exceeding those specified in column 3 of the Schedule amounting in the aggregate to the sum of Rupees <b>Eight thousand eight hundred eighty one crore forty six lakh only</b> towards defraying the several charges which will come in course of payment from 1st April to 31st July, 2024 in respect of the services specified in column 2 of the Schedule, during the financial year 2024-2025. | Withdrawal of ₹ <b>8881,46,00,000</b> from and out of the consolidated fund for the financial year 2024-2025. |
| 3. The sums authorised to be withdrawn from and out of the Consolidated Fund of the State of Arunachal Pradesh by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said 4 (four) months.   | Appropriation.  |
