PRELIMINARY NOTIFICATION

The 4th October, 2024

(Issued under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

No. LMD-13011(14)/8/2021/1184.—**WHEREAS**, the power and function of the appropriate authority under the Right to Fair Compensation and Transparency of Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the of Arunachal Pradesh which shall be exercise and discharged by him within the State.

WHEREAS, the Requiring body, SJVN Limited has sent a requisition vide No. SJVN/CC/Attunli-HEP/100/2023/05-06 dated 6th November, 2023, Ref. No. SJVN/AHEP/HR/Land-1/2024-62-64 dated 9th February, 2024 and Ref. SJVN/Attunli HEP/2024/104, dated 19th September, 2024 for acquisition of land to an extend of 247.34 Hectares/24,73,400 Sgm for C/o Atthunli Hydro Power Project (680 MW).

WHEREAS, it appears to the Government of Arunachal Pradesh that land is likely to be needed at the locality more fully described in the schedule below for C/o Atthunli Hydro Power Project (680 MW) for an area measuring 247.34 Hectares (24,73,400Sqm) located at Dibang Valley District Arunachal Pradesh. It is notified that land in the locality/localities in the schedule below is likely to be acquired for the above said purpose at expense of requiring body.

NOW THEREFORE, this notification is made under the provision of Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2023 and to all whomsoever it may concern.

The Government of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey and land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase/gift, specified in the Preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the collector.

Any person interest in the said land and whomsoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the **Deputy Commissioner**, **Anini**, **Dibang Valley District**, **Arunachal Pradesh**.

The plan of the land may be inspected at the Land Management Branch, Office of the Deputy Commissioner, Dibang Valley District, Anini.
