Notification No. 17/2023 - State Tax (Rate)

The 19th October, 2023

No. T-E-18012/6/2022.—In exercise of the powers conferred by sub-section (1) of Section 9 and sub-section (5) of Section 15 of the Arunachal Pradesh Goods and Services Tax Act, 2017 (7 of 2017), the State Government, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government of Arunachal Pradesh, Department of Tax, Excise and Narcotics, No.1/2017-State Tax (Rate), dated the 28th June, 2017, published in the Gazette of Arunachal Pradesh, Extraordinary, No. 181, Vol. XXIV, Naharlagun, Friday, June 30, 2017 namely:-

In the said notification, -

- (A) in Schedule I 2.5%,-
  - (i) after SI. No. 92 and the entries relating thereto, the following SI.No. and entries shall be inserted, namely:

"92A.	1703	Molasses";

(ii) after SI. No. 96 and the entries relating thereto, the following SI. No. and entries shall be inserted, namely:

"96A.	1901	Food preparation of millet flour, in powder form, containing atleast 70% millets by weight, pre-packaged and labelled";

- (B) in Schedule III 9%,
  - (i) against SI. No.13, in column(3), for the words and figures "of heading1905",the words and figures "of heading 1905; food preparation of millet flour, in powder form, containing atleast 70% millets by weight, pre-packaged and labelled" shall be substituted;
  - (ii) after SI. No. 25 and the entries relating thereto, the following SI. No. and entries shall be inserted, namely:-

"25A.	22071012	Spirits for industrial use";

- (C) in Schedule IV-14%, SI. No.1 and the entries relating thereto shall be omitted.
- 2. This notification shall come into force with effect from the 20th day of October, 2023.
