No. MED/NS/02/2022.—. **WHEREAS**, there has never been any Roster maintain for directly recruited posts like Nursing Officer, Clinical Instructor and Public Health/Health and Wellness Officer and ANM.

WHEREAS, the four member committee constituted vide No. MED/NS/02/2022, dated 7th June, 2022, has recommended for initiation of 100 points Roster for the posts stated above with effect from August, 2017 just after the regularization of Contractual Nurses working under NHM in compliance of Cabinet decision No. CAB/M-16/2016/45-66, agenda No. 18 date 12th January, 2017.

NOW, THEREFORE, the Roster shall be maintained with following points;

1. Date of 100 points Roster shall be effect from 1st August, 2017 onwards.
2. The Roster of 20:80(1:4) shall be maintained as per Government norms notified from time to time.
3. The Reservation shall be as per Government norms, notified from time to time.
 - (a) The 4%Reservation for PWD as per PWD Act. 2016 and 5% for meritorious Sports person shall be maintained.
 - (b) However nursing being unique profession, the Reservation percentage for PWD shall be limited to 40-50% locomotors disabilities only as per Indian Nursing Council Guidelines.
4. In case of non-availability of person under reservation stated at Sl. No. 3 above , the post shall be absorbed under general quota.
5. In case of ANM, Sl. No. 2 shall not be applicable as all ANM at Village be domicile of area as per INC Guidelines.

THEREFORE, any appointment and promotions of all categories of Nurses shall strictly be maintained accordingly herein after.

No. HTE-17/3/2021/338-49.— On recommendation of the Search Committee in terms of Section 4 (2) of the Arunachal Pradesh Private Educational Institutions (Regulatory Commission) Act, 2017 the Governor of Arunachal Pradesh is pleased to appoint **Dr. Joram Aniya Tana**, Associate Professor, Dera Natung Government College, Itanagar as **Member** in the Arunachal Pradesh Private Educational Institutions Regulatory Commission **on Deputation basis** in the revised Pay Matrix Level -16 (₹ 2,05,400-2,24,400) per month plus other allowances as admissible as per rules in force.

The terms and condition of appointment are as follows :

- (a) The appointment shall be for a period of 3 (three) years or until she attains the age of 65 years, whichever is earlier.
- (b) After expiry of the term of her office, she shall not be eligible for further employment or any assignment in any of the Private Educational Institutions within Arunachal Pradesh or their associate offices or companies within or outside Arunachal Pradesh for a period of 3 years, as per provision of the Act, 2017.
- (c) The appointment shall be for a period of 3 (three) years from the date of joining in the Arunachal Pradesh Private Educational Institutions Regulatory Commission. The deputation is however, liable to be terminated at any time without assigning any reason, if so desired by the appointing authority as per rule.
- (d) The department will accept the liabilities for payment of leave salary contribution and pension contribution if any at the appropriate rate during the period of deputation.
- (e) The appointee shall join in the Arunachal Pradesh Private Educational Institutions Regulatory Commission within one month from the date of issue of this order failing which her appointment order shall automatically stand cancelled.

The Appointment will be further subject to:-

- (1) Production of medical fitness certificate from the Medical Board authorized by the Government of Arunachal Pradesh. However, those who are already in Government Service need not to produce a fresh Medical certificate.
- (2) Submission of declaration in the form (Annexure – I) enclosed and in the event of the candidate having more than one spouse the appointment will be subject to her being exempted from the relevant Rules of CCS (Conduct) Rules, 1964.

Subject :- Empowering the Deputy Commissioner of the respective District to suspend the subordinate officers of various departments in the District.

No. AR-33/2025-SECT.-1-AR(Comp No. 219757).— **WHEREAS**, Instances of misconduct by various Officers serving in the Districts have come to the notice of the Government;

AND WHEREAS, despite such misconduct, the Deputy Commissioners are not empowered to place such officers under suspension which hampered the smooth functioning of the administrative works in the Districts;

AND WHEREAS, Rule 10 (1) of the Central Civil Services (Classification, Control and Appeal) Rules, 1965 provides that "The Appointing Authority or any authority to which it is subordinate or the Disciplinary Authority or any other authority empowered in that behalf by the Governor, by general or special order, may place a Government servant under suspension".

NOW, THEREFORE, in exercise of the powers conferred under Rule-10 (1) of the Central Civil Service (Classification, Control and Appeal) Rules, 1965 as amended from time to time, the Governor of Arunachal Pradesh is pleased to empower the Deputy Commissioners of the respect District to place the subordinate officers of various Departments, under suspension (except All India Service Officer, Arunachal Pradesh Civil Service Officers, Arunachal Police Service Officers and Arunachal Pradesh Forest Service Officers) posted in the Districts, subject to following conditions:-

- (I) The suspension should be based upon a Preliminary Inquiry that has been caused to be conducted by the Deputy Commissioner on the alleged misconduct of the Subordinate Officer.
- (II) The Deputy Commissioner should satisfy himself/herself about the necessary requirements for suspending the officer, as specified in Rule-10 (1) of the Central Civil Services (Classification, Control and Appeal) Rules, 1965 as amended from time to time.
- (III) The Deputy Commissioner shall report the facts of each case clearly specifying the specific causes of misconduct and the reasons warranting immediate suspension to the concerned Disciplinary Authority along with the report of the Preliminary Inquiry with a copy to the concerned Principal Secretary/Commissioner/Secretary of the Department, not later than fifteen days from the date of suspension.
- (IV) The Competent Disciplinary Authority on receipt of the report from the Deputy Commissioner shall review and consider the report and pass an appropriate order, either confirming the suspension or nullifying the suspension order issued by the Deputy Commissioner within thirty days of the issuance of suspension order by the Deputy Commissioner.
- (V) The suspension shall become ab initio void unless confirmed by the Competent Authority within a Period of one month from the date of the orders and the suspension shall formally revoked by the concerned Deputy Commissioner under Rule 10 (5) (c) of the Central Civil Services (Classification, Control and Appeal) Rules, 1965 in such circumstances.
- (VI) The Deputy Commissioner shall, within three months (90 days) of issuance of the suspension order, send a draft charge sheet to the concerned Disciplinary Authority with specific Article of Charges and the substance of the imputations of misconduct or misbehavior into distinct articles of charge(s) in the prescribed format under Central Civil Services (Classification, Control and Appeal) Rules, 1965 along with necessary evidence to hold an inquiry or initiating Disciplinary proceedings/Departmental proceedings against the Government servant under Rule 14 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965.
