Guidelines for the Arunachal Karmayogi Samman Nidhi will be as under:-

1. The Contingency/ALC and Casual Labour must have served not less than 20 (twenty) years of continuous services till attaining 60 years of age with annual 1 (one) day service break for availing Arunachal Karmayogi Samman Nidhi.
2. The benefits under this scheme shall be effective from 1st April, 2025.
3. The Expenditure will be borne from the State Exchequer.
4. Respective Head of Office and Head of Department shall ensure to submit individual proposals for providing funds at least 6 (six) months before attaining 60 Years of age in each case to FD (Budget) for allocation of the fund under the scheme as per format at Annexure "B".
5. The financial benefits must be provided on the day of his exit from service.
6. Acknowledgement on disbursement of the amount to the benefited employees in his account must be submitted to FD (Budget) for records.

No. HPD (M)-12/29/2023/Comp No. 154020/352-65.— In exercise of the powers conferred by Clause 9.14 of the Hydro Power Policy, 2008 and amended Clause 28(6) of the Small Hydro Power Policy 2007, the Governor of Arunachal Pradesh hereby makes the following amendments in the notification No. SHPD/E-74/2019/2789-97 dated 17th June, 2022, published in the Arunachal Pradesh Extraordinary Gazette No. 12, Vol. XXXIII, Naharlagun dated 30th June, 2022 notifying the creation of Local Area Development Fund Guidelines for Hydro Electric Projects in Arunachal Pradesh, 2022.

In the Local Area Development Fund Guidelines for Hydro Electric Projects in Arunachal Pradesh, 2022, in Section 2. Composition of Local Area Development Fund, the Clause 2(b) and 2(c) shall be substituted by the following, namely:

Clause - 2(b): For the project >25 MW, the developer shall contribute 1% of the proceeds from power generation to the LADF during the commercial operation life of the Hydro Electric Project. In addition, the developer will contribute an **additional 1%** of the proceeds of power generation to the LADF **on behalf of the State Government and debit the same against the 12% free power due to the State** during the commercial operation life of the Hydro Electric Project. The remaining 11% free power due to the State shall continue to be deposited with the State Government, as per the MoA/MoU signed between the State Government and the developer, as the case may be.

Clause 2(c) : The revenue to be deposited in the LADF for a project for a particular year will be based upon the average price per unit. The average price per unit will be worked out as per the **rate decided by the regulator** (presently CERC) for that particular project for the Financial Year for which the contribution is to be made. The contribution into LADF will be made by the developer on behalf of the State Government, preferably on a **quarterly basis** and mandatorily on an annual basis.

This Notification shall deem to have come into force with effect from date of publication.
