ORDER

No. T-E-11015/20/2023.—**WHEREAS**, Shri Gautam Das, Driver was posted in the Office of the Superintendent (Tax, Excise & Narcotics), Boleng, Siang District from 13th August, 2018 to 13th June, 2023.

AND WHEREAS, on dated 3rd April, 2023, Late Kaman Tayeng, Superintendent (T, E & N), Boleng, Siang District met with an accident in her Government vehicle leading to her untimely demise. Later it was reported that Shri Gautam Das, Driver attached with the officer was not present on duty on the fateful day of accident. Consequently, a letter was written to Assistant Commissioner, Pasighat Division vide order No. TAX (E)-488/2012 dated 10th April, 2023, wherein he was directed to investigate the matter and submit a Summary Report regarding the incident.

In compliance, a Summary Report was submitted by the Assistant Commissioner wherein it was found that the deceased herself was driving the Government vehicle due to absence of Driver, Shri Gautam Das who failed to join the duty upon expiry of his leave on 23rd March, 2023. It was also reported that Shri Gautam Das was admitted to Abundant Life Rehabilitation-cum-Counselling Centre, Jairampur, Changlang with effect from 8th October, 2022 for Drugs/Alcohol Dependency and Psychotropic substances abuse.

AND WHEREAS, an Inquiry under Rule 14 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965 was initiated against Shri Gautam Das, Driver on the following Article of Charges :

1. "Shri Gautam Das, Driver was absent from duty on 3rd April, 2023 (the day of accident in which Late Smti Kaman Tayeng, Superintendent, Boleng died). The report of Shri Tabor Tapak, Assistant Commissioner (Tax, Excise & Narcotics), Pasighat revealed that Shri Gautam Das was on earned leave for 90 days with effect from 8th November, 2022 to 5th February, 2023 and later extended for another 45 days with effect from 6th February, 2023 to 23rd March, 2023 on medical ground. After the expiry of leave he neither joined his duty nor applied for extension of leave. Being on unauthorized leave is unbecoming of a Government servant and amount to misconduct. Willful absence from duty after the expiry of leave renders a Government servant liable to disciplinary action".

2. "The officer with whom Shri Gautam Das, Driver was attached has observed and informed that Shri Gautam Das, Driver has been found to be a habitual user of intoxicating drinks and drugs for a long time. Shri Tanon Tatak, DC has stated that Shri Gautam Das, Driver was attached with him during 2011-2012 but due to substance use he relieved him from duty".

3. Shri Gautam Das, Driver has been admitted in Abundant Life Rehabilitation-cum-Couselling Centre, Jairampur, Changlang with effect from 8th October, 2022 due to drug and alcoholic dependency which strongly support the fact that Shri Gautam Das is a habitual user of drugs and alcohol."

AND WHEREAS, an inquiry Officer was appointed to inquire into the charges framed against the charged Official vide order No. T-E-11015/20/2023-Dept T-E-N-TAX & EX dated Itanagar, the 29th September, 2023.

AND WHEREAS, the Inquiry report conducted under Rule – 14 of the CCS (CCA) Rules, 1965 was submitted by the Inquiry Officer, the charge under Article – I was not proved while the Charges under **Article – II and III were proved.**

AND WHEREAS, a copy of the Inquiry Report was forwarded to the Charged Officer under Rule 15 (2) of the CCS (CCA) Rules, 1965 with a direction to submit his written submission if any within 15 days vide order No. T-E-11015/20/2023-Department T-E-N-TAX and EX dated 5th November, 2024.

AND WHEREAS, the charged official in his reply denied all the charges against him and also contested that the statement by Shri Tanon Tatak, the then DC (T, E, and N) to be unsustainable. The said submissions of Shri Gautam Das have been carefully considered and various issues raised by him have been examined in the light of records of the case.

AND WHEREAS, on careful consideration of the report of the Inquiry Officer and other records of the case in the light of the submissions made by Shri Gautam Das in his reply and during his personal hearing, the undersigned has decided to accept the findings of the Inquiry Officer in respect of the Article(s) of charges II and III and holds that these charges against Shri Gautam Das stands **proved.**

NOW THEREFORE, the Governor of Arunachal Pradesh, in exercise of powers conferred by the Rule 15 (4) read with Rule 22 of Central Civil Services (Conduct) Rules, 1964 and after taking into consideration all facts and circumstances of the case and after examining all documents placed on record and after being totally convinced with the recommendation of the Inquiry Officer and keeping in view the sensitivity and seriousness of the matter and grave misconduct and also in violation of Rule 22 of Central Civil Services (Conduct) Rules, 1964 committed by the charged officer, hereby impose the penalty of Compulsory Retirement with admissible pensionary benefits upon Shri Gautam Das, Driver with immediate effect.

 - “Appellate Authority” means Commissioner to the Government, Department of Industries, Government of Arunachal Pradesh or Secretary to Government in the absence of a commissioner in the Department of Industries, Government of Arunachal Pradesh authorized as the Appellate Authority under sub-section (1) of Section 26B of the Act ;
 - “ Chief Inspector” means a person appointed to be a Chief Inspector under the Act ;
 - “Inquiry” means the inquiry mentioned in Section 26A of the Act ;
 - “Inspector” means a person appointed to be an Inspector under the Act ;
 - “Owner” shall have a meaning assign to it under clause(d) of Section 2 of the Act ;
 - “Form” means a form appended to the these rule ;(2) Words and expressions used and not defined in these rules, but defined in the Act shall have the same meanings respectively assigned to them in that Act.
- Applicability of rules :** These rules shall be applicable to whole state of Arunachal Pradesh.
- Adjudication proceedings under Section 26A :** (1) On receipt of a report from the Inspector, the Chief Inspector shall examine the case according to the provisions of the Act, rules and regulations made thereunder under which the owner(s) has been charged as to whether the contraventions are punishable with penalty under Sections 22, 23, sub-section (1) of Section 25 or Section 30 the Act or no contravention is established.
 - If the Chief Inspector decides that such contravention is punishable with penalty under Sections 22, 23, sub-section (1) of Section 25 or Section 30 of the Act, he shall cause and authorize the Inspector to file with the Adjudicating Officer in **Form-I**, an application for adjudication of the offence alleged to have been committed by the person in respect of which the report has been received through electronic means or speed post or by hand.
 - On receipt of the communication from the Chief Inspector authorizing the filing of the adjudication application in **Form-I**, the Inspector shall file the application for adjudication with the Adjudicating Officer for adjudication of the contravention alleged to have been committed.
 - On receipt of the application for adjudication from the Inspector, the Adjudicating Officer shall commence the inquiry proceedings under Section 26A of the Act.

- (5) For holding an inquiry for the purpose of adjudication under Section 26A of the Act as to whether any owner(s) has or have committed contravention of any of the provisions of Sections 22, 23, sub-section (1) of Section 25 or Section 30 the Act in respect of which the contravention is alleged to have been committed, the Adjudicating Officer shall, in the first instance, issue a notice in **Form-II** to such owner(s) giving him or them an opportunity for hearing in the matter within a period of one month.
- (6) The notice to such owners(s) shall indicate the nature of offence alleged to have been committed by him or them, the sections of the Act alleged to have been contravened and the date of hearing of the matter. A copy of the report of the Inspector shall also be annexed to such notice.
- (7) On the date fixed for hearing, the Adjudicating Officer shall explain to the owner(s) or to his authorized representative, the offence alleged to have been committed by such person, indicating the provision of the Act in respect of which the contravention is alleged to have taken place.
- (8) The Adjudicating Officer shall then give an opportunity to such owner(s) to produce such documents or evidence in **Form-III** as he may consider relevant to the inquiry and if necessary, the hearing may be adjourned to a future date.

Provided further that the Adjudicating Officer shall pass the final order within 180 days from the date of first hearing mentioned in sub-rule (7) above.

- (9) While holding an inquiry under this rule, the Adjudicating Officer shall have the power to summon and enforce the attendance of any person acquainted with the facts and circumstances of the case to give evidence or to produce any document which, in the opinion of the Adjudicating Officer may be useful for or relevant to the subject matter of the inquiry.
 - (10) If any person fails, neglects or refuses to appear as required by sub-rule (5) and (6) before the Adjudicating Officer, the Adjudicating Officer may proceed with the inquiry in the absence of such person, after recording the reasons for doing so.
 - (11) If upon consideration of the evidence produced before the Adjudicating Officer, the Adjudicating Officer is satisfied that the owner, against whom the Inquiry has been conducted, is liable to penalty under any of the provisions of Sections 22, 23, sub-section (1) of Section 25 or Section 30 the Act, he may, by order in writing, impose such penalty as he thinks fit, in accordance with the provisions of the relevant section or Sections of the Act.
 - (12) If, however, the Adjudicating Officer is satisfied that the owner(s) against whom the inquiry has been conducted for the contravention of provisions of the Act, has or have not been proved beyond doubt, the Adjudicating Officer shall dismiss the case.
 - (13) Every order made under sub-rule (11) shall specify the provisions of the Act in respect of which the contravention has taken place and shall contain brief reasons for such decision. While imposing penalty, the Adjudicating Officer shall have due regard to the provisions of Section 26A of the Act. Such penalty shall be remitted in the form of treasury challan in the Head of Account "**0230 Labour & Employment 103-Fee for inspection of Steam Boiler**", Accountant General, Itanagar.
 - (14) Every such order shall be dated and signed by the Adjudicating Officer.
 - (15) The Adjudicating Officer shall send a copy of the order made under sub-rules (11) or (12) to the owner(s) against whom the inquiry was conducted and the Inspector who has filed the application for adjudication,
 - (16) A notice or an order issued under these rules shall be served on the owner(s) against whom the adjudication proceedings were held or inquiry has been conducted, in any of the following manner:
 - (i) by delivering or tendering it to that owner(s) or his duly authorized representative; or
 - (ii) by sending it to the owner(s) by registered post or speed post to the address of his place of residence or his last known place of residence or the place where he carried on or last carried on, business or personally works or last worked for gain; or
 - (iii) if it cannot be served in the manner specified under sub-rule (i) or (ii), by affixing it on the outer door or some other conspicuous part of the premises in which that person resides or is known to have last resided or carried on business or personally works or has worked for gain and written report thereof should be witnessed by two persons.
5. **Procedure for Appeal under Section 26B of the Act :** (1) An appeal under Section 26B of the Act, arising out of a decision of the Adjudicating Officer appointed under Section 26A of the Act, shall be filed with the Appellate Authority in **Form-IV** within a period of sixty days from the date on which the copy of the order against which the appeal is filed, is received by the appellant in the manner specified at Rule 4 (16).
- (2) An appeal may be admitted after the expiry of the period of sixty days if the appellant satisfies the appellate authority that he had sufficient cause for not preferring the appeal within that period.

- (3) The appeal shall be accompanied by a copy of order of Adjudicating Officer issued under sub-rule (11) of rule 4 and a clear statement of facts appealed against, the grounds for appeal and the relevant sections of the Act.
- (4) The appeal shall be presented in triplicate by the appellant in person or by his duly authorized agent in writing or by an advocate duly appointed in this behalf or by registered post or speed post and shall be accompanied, wherever applicable, with the stipulated fee.
- (5) The appeal sent by post shall be deemed to have been presented to the Appellate Authority on the day it is received.
- (6) If on scrutiny, the appeal is found to be in order, it shall be duly registered and given a registration number.
- (7) If on scrutiny, the appeal is found to be defective, the same shall, after notice to the party, be returned for compliance and if within 21 days of receipt of such notice or within such extended time as may be granted, the defect is not rectified, the Appellate Authority, may, for reasons to be recorded in writing, decline to register the appeal.
- (8) A copy of the Appeal shall be served by the Appellate Authority on the Respondent as soon as it is registered, by hand delivery or by Registered post or speed post.
- (9) On admission of the appeal, the Appellate Authority may call for the records relating to the proceedings from the respective Adjudicating Officer.
- (10) Respondent may, within thirty days of service of notice of appeal, file reply on the appeal to the Appellate Authority.
- (11) The Appellate Authority may, after giving the parties to the appeal an opportunity of being heard, pass such orders as he may think fit, confirming, setting aside the order appealed against.
- (12) The order of the Appellate Authority shall be signed and dated. The Appellate Authority shall have powers to pass interim orders or injunction, subject to reasons to be recorded in writing, which he considers necessary in the interest of justice.
- (13) A certified copy of every order passed by the Appellate Authority shall be communicated to the Adjudicating Officer and to the parties, as the case may be.
