OFFICE MEMORANDUM

The 21st July, 2025

No. LLJ-11024(11)/4/2025/353.—WHEREAS it has been noticed that on most of the occasions, various Government Departments are endorsing urgent files pertaining to vetting of Assembly Bills, Cabinet notes, MoUs, Parawise comments, Professional bills, Legal advice files etc. to this Department at the very last hour and seeking early clearances which prevents the officers of the Department from examining the issues in-depth. The vetting by Law Department is a time taking exercise and any un-due hurry may lead to mistakes and oversights.

In view of above, it is felt that an OM be issued indicating the timelines and modalities of the examination/ vetting of such proposals.

Accordingly, on the approval of the Competent Authority, this OM shall henceforth be used as a reference for examination of the various proposal for vetting by this Department superseding the previous Law Department Circular No. JUD-89/98 PART dated 10th August, 2023.

1. **VETTING OF LEGISLATIVE BILLS :**

- (a) The Departments initiating any new assembly bills/amendment bills may send the file, duly completed in all respects, to Law Department at least one (1) month prior to the start of the next Assembly sessions.
- (b) The Department shall assign one responsible Officer, well conversant with the matter, to coordinate with the Law Department till the bill is passed by the Legislative Assembly and a formal notification of the Act is published in the Arunachal Pradesh Gazette.
- (c) All the Legislative Bills sent for vetting should be sent only in an **editable format** (in e-office draft format) for facilitating corrections etc.

2. VETTING OF CABINET NOTE.

- (a) All Cabinet Notes sent for Law vetting should contain the Administrative Approval of the authority, clearance of AR Department and Finance Department.
- (b) The Cabinet Note should be in the latest format as circulated by the Cabinet Cell.
- (c) The Cabinet Note should be sent at least 10 days prior to the Cabinet Meeting.
- (d) The Cabinet Note sent for vetting should be sent only in an **editable format** (in e-office draft format) for facilitating corrections etc.

3. VETTING OF MOU/MOA :

- (a) All Department should obtain prior Administrative Approval of the Hon'ble Minister-in-charge of the Department for entering into MoU/MoA on behalf of the State Government with any entity.
- (b) In case, the MOA/MOU etc contains financial implications, prior clearance of Finance Department must be obtained.
- (c) The MoA/MoU should be sent to the Law Department for vetting at least 15 days prior to signing of such agreement.
- (d) All the MoU/ MoA sent for vetting should be sent only in an **editable format** (in e-office draft format) for facilitating corrections etc.

4. VETTING OF PARA-WISE REPLIES/COMMENTS :

- (a) If any case is filed against the Government, it will be the duty of the Department Counsel to contest the case with all the material facts of the matter and to file the counter affidavit in time. There should be proper co-ordination with the Government Counsel and directions of the Hon'ble Court for filing reply/rejoinder should be complied with within the given time-frame.
- (b) The para-wise comments, with all the supporting annexures (petition copy, orders etc), should be sent to the Law Department for vetting at least 10 days before the same is finalized by the Department in consultation with the concerned Government Advocate.
- (c) The Department should ensure that the para-wise replies sent to the Law Department must be in an **editable format** (in e-office draft format).

5. SEEKING OF LEGAL ADVICE/OPINION :

- (a) In case of any query sent to the Law Department which involves court cases, the Department should invariably send the petition copy and any other orders issued by the court in the matter along with a self-contained note of the Department for examination of Law Department.
- (b) The Department should frame/indicate in clear terms the queries/legal issues on which the opinion/ advice of the Law Department is required/sought. Further the Department should clearly give its point of view on the subject instead of leaving everything open to interpretation.
- (c) In case of opinion on service matters, the same should have been firstly examined by the AR Department.

6. VETTING OF RECRUITMENT RULES/NOTIFICATIONS/GUIDELINES/BYE-LAWS :

- (a) In matters relating to vetting of RRs, in case of any changes by the AR Department, the changes should be incorporated in the draft endorsed to Law Department for vetting thereto along with the copy of the principal Recruitment Rules and all the subsequent amendment(s) made thereto. In cases where clearance from FD/APPSC/APSSB is required, the process of obtaining such clearance should be firstly completed prior to endorsing for Law Vetting.
- (b) The draft R/R is to be sent in an **editable format** (in e-office draft format).
- (c) The draft number(s) of any and all draft(s) attempted by the Department which has/have been endorsed to the Law Department for vetting, should be clearly and specifically mentioned in the file noting.

7. VETTING OF PROFESSIONAL BILLS :

The department while endorsing any files for vetting of the professional bills of any Government advocate(s) should place in the file, a copy of the pre-negotiated rates and the engagement order of the Advocate(s) along with the administrative approval of such rate/engagement order.

Note : 1. In case of non-fulfillment of any of the pre-requisites stated above, the Law Department shall return the file without vetting/ examination and the delay in such cases shall be attributable to the administrative Department for not adhering to the guidelines as prescribed by Law Department.

2. The Check-list and Timelines at **Annexure-I** may be referred and adhered to.

No. DTH-11011/11/2023(E-161628).—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules to amend the Arunachal Pradesh Textile and Handicrafts Department (APT&H) Service Rules, 1999 namely : -

1. **Short title and commencement** : (1) These rules may be called the Arunachal Pradesh Textile and Handicrafts Department (APT&H) Service Rules (Amendment) Rules, 2024.
(2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
2. **Amendment** : In the Principal Service Rules notified vide No. DTH/ESTT/102/250 dated 22nd July, 1999 hereinafter referred to as Principal Rules: - (i) In **Rule-8** for the existing entry, the following entry shall be substituted: **“Appointment to the post of Director of Textile and Handicrafts shall be made by promotion on the principle of selection from amongst the Joint Director of Textile and Handicrafts who have rendered not less than 5 (five) years of regular service in the grade. Failing which, by promotion from the post of Joint Director of Textile and Handicrafts with a combined regular service of 10 years as Joint Director and Deputy Director of Textile and Handicrafts with minimum regular residency period of 3 (three) years as Joint Director of Textile and Handicrafts.**

Further failing which by transfer on deputation from the Officers of the Central Government, State Government or Union Territories holding analogous post in the parent cadre or Department with 5 (five) years regular service in Level -12 ₹ 78,800- 2,09,200 PM and possessing the required qualification and experience.

The period of deputation shall ordinarily not exceed 3 (three) years.

- (ii) In **Rule - 9** for the existing entry, the following entry shall be substituted: - **“Appointment to the post of Joint Director of Textile and Handicrafts shall be made by promotion on the principle of selection from amongst the Deputy Directors of Textile and Handicrafts who have rendered not less than 5 (five) years of regular service in the grade.**

Failing which, by promotion from the post of Deputy Director of Textile and Handicrafts with a combined regular service of 10 years as Deputy Director of Textile and Handicrafts and Assistant Director of Textile and Handicrafts with minimum regular residency period of 3 (three) years as Deputy Director of Textile and Handicrafts.

Further failing which by transfer on deputation from the Officers of the Central Government, State Government or Union Territories holding analogous post in the parent cadre or Department with 5 (five) years regular service in Level-11 ₹ 67,700 - 2,08,700 PM and possessing the required qualification and experience.

The period of deputation shall ordinarily not exceed 3 (three) years.
