DECLARATION

The 27th March, 2025

(Under Section (19) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/46/2024.—**WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total of 146400.00 Sqm of land is required at **Lungrola to Triple Height BRTF Road** in Shocktsen Village under Zameithang Circle Tawang District for public purposes only.

**AND WHEREAS**, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide Memo No.LMD-13011/46/2024/1736 dated 24th December, 2024 notifying the intention of the State Government for acquiring of 146400.00 Sqm of the said land and inviting public claims and objections to the proposed acquisition of land if any.

**AND WHEREAS**, the Deputy Commissioner, Tawang District, vide his Memo No. TLR-70/2013-14/2943-44 dated 1st August, 2024 certified that land is a community land and free from public and Government projects and that there are no project affected families and therefore no compensation towards Rehabilitation and Resettlement are required to be paid under Section 31 of the LARR Act, 2013 and has requested the State Government to issue the declaration under Section 19 of the LARR Act, 2013.

**AND WHEREAS**, the Appropriate Government is pleased to note that it is satisfied that Chapters-II and III and Section-15 and 16 shall not apply to acquisition process in respect of the said land Lungrola to Triple Height BRTF road.

**AND NOW**, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act, specifying that the piece of land measuring 146400.00 Sqm located at Lungrola to Triple Height BRTF road in Shocktsen Village under Zameithang Circle, Tawang District is being acquired and the detailed description whereof is as follows :-

- (i) Except such parts of the mines and minerals which may be required to be dug or removed or used during construction phase of the project for the purpose of which land is being acquired, no mines, minerals, iron, stone, slate and other minerals lying under the said land shall be extracted or removed.
- (ii) A plan of the land may be inspected in the office of the Collector and DLRSO, Tawang District on any working day during the working hours.
