DECLARATION

The 3rd October, 2024

(Under Section (19) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013).

No. LMD-13011/47/2023/1179.—**WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total 50 Hectares (500000 Sqm) for Tato-I HEP (186MW) and 57.2 Hectares (572000 Sqm) for Heo HEP (240MW) of land are required at Tato and Rapum Circle under Shi Yomi District for public purposes namely for construction of Hydro Electric Projects by the NEEPCO.

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide Memo No. LM-317/2016/833 dated 26th September 2019 and notifying the intention of the State Government for acquiring of 50 Hectares (500000 Sqm) for Tato-I HEP(186MW) and 57.2 Hectares (572000 Sqm) for Heo HEP (240MW) of the said land and inviting public claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Shi Yomi District, vide his Memo No.SHY/LM-23/Tato-I and Heo/2023 dated 12th September, 2024 certified that land is a private land and free from public and Government projects and that there are no project affected families and therefore no compensation towards Rehabilitation and Resettlement are required to be paid under Section 31 of the LARR Act and has requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring 50 Hectares (500000 Sqm) for Tato-I HEP(186MW) and 57.2 Hectares (572000 Sqm) for Heo HEP (240MW) located in Tato and Rapum Circle, Shi Yomi District is being acquired, the detailed description whereof is as follows:-
