DECLARATION

The 30th August, 2024

(Under Section 19 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/26/2024/887.—WHEREAS, it appears to the Governor of Arunachal Pradesh that a total of 107.315 Hectares (10,73,150 Sq mtrs) of land is required at Huri, Chate, Huba, Bamo Villages under Damin and Parsi-Parlo Circles of Kurung Kumey District for public purposes namely :-Construction of Frontier Highway Huri -Taliha.(From 0.000 KM to 28.500 KMs)

WHEREAS, a Preliminary Notification as required under Section 11(1) read with Section 40(1) of LARR Act, 2013 was issued by the Department of Land Management vide Memo No. LMD -13011/26/2024/345 dated Itanagar the 25th June, 2024 notifying the intention of the State Government for acquiring of 107.315 Hectares (10,73,150 Sq mtrs) of the said land and inviting public claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Kurung Kumey District vide his Memo No. KKD/LM/FH/49/2023-24/1923 dated the Koloriang on 16th May, 2024 certified that land is a private land and free from public and Government projects and that there are no project affected families and therefore no compensation towards Rehabilitation and Resettlement of Huri, Chate, Huba, Bamo, Villages are required to be paid under Section 31 of the LARR Act and has requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters -II and III and Section -15 and 18 shall not apply to acquisition process in respect of the said land at Huri, Chate, Huba, Bamo for construction of Frontier Highway namely :- Huri-Taliha.

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring **107.315 Hectares** (10,73,150 Sq mtrs) located at Huri, Chate, Huba, Bamo, Villages under Damin and Parsiparlo Circles of Kurung Kumey District is being acquired, the detailed description whereof is as follows:-

The Governor of Arunachal Pradesh is further pleased to order as under :-

- (i) Except such parts of the mines and minerals which may be required to be dug or removed or used during construction phase of the project for the purpose of which land is being acquired, no mines, minerals, iron, stone, slate and other minerals lying under the said land shall be extracted or removed.
- (ii) A plan of the land may be inspected in the office of the Collector and DLRSO, Kurung Kumey District on any working day during the working hours. The provisions of the Chapter-II and III and Section 15 to 18 of the Act shall not apply to the acquisition in respect of the above land since the land is acquired by the MoRTH in exercise of the powers conferred by sub-section (1) and (4) of Section 40 of the LARR Act, 2013.
- (iii) The Collector (Deputy Commissioner) through no award has been made, may, on expiration of thirty days from the date of publication of the notice mentioned in Section 21, take possession of any land needed for a public purpose and such land shall thereupon vest absolutely in the Government free from all encumbrances.
- (iv) No additional compensation will be paid as per Section 40(5) of the LARR Act, 2013 since the acquisition affects the sovereignty & integrity of India and the security and strategic interest of the State.
