DECLARATION

The 25th MArch, 2025

(Under Section 19(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/39/2024/2555.— **WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total of 102000.00 Sqm of land for construction of Road and 19800.00 Sqm for Muck Disposal Area is required at Klemta-PT 4634 BRTF Road in Shar-Tso under Tawang Circle, Tawang District for public purposes.

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide Memo No. LMD-13011/39/2024/2143 dated 14th February, 2025 notifying the intention of the State Government for acquiring of 102000.00 Sqm of land for construction of road and 19800.00 Sqm for Muck Disposal Area inviting claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Tawang District, District vide his Memo No. TLR-70/2013-14/4119 dated 10th September, 2024 certified that the land is a community land and free from public and Government projects and that there is no project affected families and therefore no compensation towards Rehabilitation and Resettlement are required to be paid under Section 31 of the LARR Act, 2013 and has requested that State Government to issue the declaration under Section 19 of the LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters-II and III and Section -15 and 16 shall not apply to acquisition process in respect of the said land Klemta-PT 4634 BRTF Road in Shar-Tso under Tawang Circle.

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring 102000.00 Sqm for construction of road and 19800.00 Sqm for Muck Disposal Area located at Klemta-PT 4634 BRTF Road in Shar-Tso under Tawang Circle, Tawang District is being acquired and the detailed description whereof is as follows :-
