#### **CORRIGENDUM NOTIFICATION**

The 19th March, 2025

No. LMD-13011(12)/5/2021/2386.— **WHEREAS**, a Preliminary Notification under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (LARR Act, 2013) was issued vide Notification No. LMD-13011(12)/5/2021/437, dated 10th July, 2024, for the acquisition of 237.022 hectares (2,370,220 Sqm) of land in Tali and Pipsorang Circles of Kra-Daadi District, Arunachal Pradesh, for the construction of the Huri-Taliha Frontier Highway (Package-III) by the Border Roads Organization (BRO), invoking the urgency clause under Section 40 of the Act;

**AND WHEREAS**, upon further verification, it has been found that an additional 30.81 hectares (308,104 Sqm) of land, falling under the administrative jurisdiction of Kra-Daadi District, was inadvertently notified under the jurisdiction of Upper Subansiri District (Package-IV) vide Notification No. LMD-13011(11)/4/2024, dated 10th July, 2024;

**AND WHEREAS**, a consultative meeting was held on 11th February, 2025 between the District Administrators of Upper Subansiri and Kra-Daadi Districts along with stakeholders to discuss the administrative jurisdiction issue pertaining to the Land Acquisition Notification for Huri-Taliha Frontier Highway (chainage 113.250 km to 119.525 km). It was confirmed that the chainage from 113.250 km to 119.525 km falls entirely under the administrative jurisdiction of Kra-Daadi District. Accordingly, the Kra-Daadi District administration will oversee the Land acquisition for the said chainage.

**AND WHEREAS**, to correct this administrative oversight and ensure the rightful inclusion of the 30.81 hectares under the Kra-Daadi acquisition process, the Government of Arunachal Pradesh deems it necessary to issue a corrigendum notification under Sections 11(2), 19, 21 and 40 of the LARR Act, 2013 to rectify and appropriately reallocate the land acquisition areas between Kra-Daadi and Upper Subansiri Districts;

**NOW, THEREFORE**, in exercise of the powers conferred under Sections 11(2) and 19 of the LARR Act, 2013, the Government of Arunachal Pradesh hereby modifies/amends the earlier notifications as follows:

### 1. Correction of Land Area

- (i) The notified land area for acquisition is revised from 237.022 hectares to 267.832 hectares, incorporating the additional 30.81 hectares.
- (ii) Specific Details of the Additional Land :
  - o Location: Pane Ugu to Merig-Ugu, Pipsorang Circle, Kra-Daadi District
  - o Chainage: 113.250 km to 119.525 km (6.725 km/ 30.81 Ha)
  - o Land Use Type: Jhum Land / Private Plantation
- Modification of Declaration under Section 19: The Declaration under Section 19 issued vide Notification No. LMD-13011(12)/5/2021/1509 dated 22nd November, 2024 shall stand amended to reflect the revised total land area, as per the corrected jurisdiction.
