DECLARATION

The 17th April, 2025

(Under Section (19) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/25/2024/2337.—**WHEREAS**, It appears to the Governor that a total of **40.499 Hectrares (404990 Sqm)** land is required at Payum, Gaseng, Yio and Gate Village, Payum Circle, Kaying Taluk/Sub Division/Tehsil/Block Siang District for public purpose, namely for “**Construction of 2 - Lane (7.00 M Carriage way With Hard Shoulders) NH Configuration of Bile - Migging Road From Design Chainage Km 24.000 to Km 32.375 on Engineering, Procurement and Construction (EPC) Mode in the State of Arunachal Pradesh**” by 105 RCC(GREF), Moying, Upper Siang District.

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide Memo No. LMD-13011/25/2024/173 dated 24th May, 2024 notifying the intention of the State Government for acquiring of 40.499 Hectares (404990 Sqm) of the said land and inviting public claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the appropriate Government is pleased to note that it is satisfied that Chapters - II and III and Section -15 and 16 shall not apply to acquisition process in respect of the said land acquiition proceeding.

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring **40.499 Hectares (404990 Sqm)** located in Payum, Gaseng, Yio and Gate Village, Payum Circle, Kaying Taluk/Sub Division/Tehsil/Block Siang District is being acquired, the detailed description whereof is as follows :
