(Invoking Urgency Clause)

No. LMD-13011(11)/39/2022.—**WHEREAS**, it is appear that the Governor, that a total **11 Hectares (1,10,000 Sqmtrs)** of land is required at Mipi Circle, Anini-Mipi Taluk/Sub-Division /Tehsil/CD Block, Dibang Valley District for public Purpose, namely

Additional **10.00 KM-13.00 KM Mipi-Andrela Road Project by 62 RCC, BRTF (GREF).**

A total No. of Nil families are likely to be displaced due to the land acquisition. The reason necessitating such as is given below.

The Deputy Commissioner, Anini, Dibang Valley District, is appointed as Administrator for the purpose of Rehabilitation and Resettlement/compensation of the affected families. Therefore, it is notified that for the above said project in the Mipi Circle, Anini-Mipi Taluk/Sub-Division/Tehsil/CD Block, Dibang Valley District a piece of land measuring **11 Hectares (1,10,000 Sqmtrs)** of standard measuring, whose detailed description is as follows, is under acquisition.
