## PRELIMINARY NOTIFICATION

The 25th April, 2025

(Issued Under Section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(11)/11/2021/187.— **WHEREAS**, the power and function of the appropriate authority under the Right to Fair Compensation and transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vested in the Governor of Arunachal Pradesh, which shall be exercise and discharge by him within the State.

**WHEREAS**, the Requiring Body, BRO 105 RCC (GREF) has sent a requisition vide letter No. 2207/LA/105/57/E2 dated 28th February, 2025 for acquisition of land to an extent of **41.86 Hectares** (including muck disposal) for improvement/widening of Ditt-Dimme Migging Road from **Designed Chainage KM 69.980 to 87.740 KM** (Existing Chainage from KM 73.250 to KM 92.250) under Jengging Circle Upper Siang District.

**WHEREAS**, it appears to the Governor of Arunachal Pradesh that land is likely to be needed at the locality more fully described in the schedule below for improvement/widening of Ditt-Dimme Migging Road Package - IV, Part - II, from **69.980 KM - 87.740 KM**, total area measuring **41.86 Hectares** (including muck disposal) located at **Kolung to Moying** under Jengging Circle, Upper Siang District. It is hereby notified that Land in the locality/localities in the schedule below is likely to be acquired for the above said purpose at expense of requiring body. The summary of the social impact assessment for the locality/localities decribed in the mentioned scheduled is also included below for mentioned purpose.

**NOW THEREFORE**, this notification is made under the provision of Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concern.

The Governor of Arunachal Pradesh hereby also authorise the Officers and Officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale/purchase/gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the Collector.

Any person interest in the said land and whomsoever has any objection to the acquisition of the said land, may within 30(thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, Upper Siang District, Yingkiong.

The plan of the land may be inspected at the Land Management Branch Deputy Commissioner's/ DLRSO's Office. Upper Siang District, Yingkiong
