NOTIFICATION

No. HOME-11011/19/2025.—In exercise of th powers conferred by sub-section (1) of Section 4 of the Civil Defence Act, 1968 (hereinafter referred to as the Act), the Governor of Arunachal Pradesh hereby notifies constitution of Civil Defence Corps in the following Districts/Administrative Unit of the State and appoints the concerned District Magistrate as the ex-officio Controller of Civil Defence to command these Corps:-

In exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Arunachal Pradesh hereby appoints the Secretary of the Disaster Management Department, Government of Arunachal Pradesh, as ex-officio Director of Civil Defence for the purpose of coordinating the activities of the Controllers of Civil Defence within the State and every Controller of Defence shall comply with directions given by the Director of Civil Defence.

In exercise of the powers conferred by Section 17 (a) of the said Act, the Government of Arunachal Pradesh delegates to the Controllers of Civil Defence the power to appoint members (volunteers) of the Civil Defence Corps from amongst such persons as are fit and willing to serve as such under Section 5 (1) of the said Act.

The Controllers of Civil Defence shall plan, execute and monitor Civil Defence Measures in any area within the district and are authorised to carry out Civil Defence measures/exercises as prescribed under the Civil Defence Rules, 1968 and directions of the State and Central Governments. They shall command the District Civil Defence Corps in their respective Districts/Administrative unit in accordance with the said Act and Rules as well as Government directions.

The Director of Civil Defence shall coordinate the activities of the Controllers of Civil Defence within the State.
