The Appropriate Authority may co-opt any medical expert to assist in its functioning,as required.

The Directorate of Health Services, Arunachal Pradesh will serve as the **Secretariat** of the Appropriate Authority.

Functions of the Appropriate Authority :

As per the Transplantation of Human Organs and Tissues Act, 1994, the Appropriate Authority shall :

1. **Grant or renew registrations** to hospitals or tissue banks under Section 15 (1) and 15 (3).
2. **Suspend or cancel registrations** under Section 16(2).
3. **Enforce prescribed standards** for :
 - Hospitals engaged in removal, storage, or transplantation of human organs.
 - Tissue Banks engaged in recovery, screening, testing, processing, storage, and distribution of tissues.
4. **Investigate complaints** of breach of any of the provisions of this Act or any of the rules made there under and take appropraite action.
5. **Inspect Tissue Banks** periodically.
6. **Inspect hospitals** for evaluating :
 - Quality of transplantations.
 - Post-transplant care for recipients and donors.
7. **Undertake other measures** as may be prescribed.

The Appropriate Authority shall use the forms prescribed in the **Transplantation of Human Organs and Tissues Rules, 2014** and ensure strict and continuous compliance with the applicable standards by registered Hospitals and Tissue.
