#### **NOTIFICATION**

The 10th July, 2025

No. HOME-12026/2/2025/Part(2).—In exercise of powers conferred under Section 64 of the Bharatiya Nagarik Suraksha Sanita, 2023, the Governor of Arunachal Pradesh is pleased to make the following Rules, namely:

- **1. Short title and commencement**: (1) This rule may be called the Arunachal Pradesh Form of Summons and Manner of Serving Summons Rules, 2025.
  - (2) It shall come into force on the date of its publication in the Official Gazette.
- 2. In case of summons to an accused person to be served by court, every such summons shall be served in the Form I or I A, by the presiding officer of the Court (or such other officer as may be directed by the High Court) issuing the summons. In case of summons to an accused person to be served by an executive magistrate, every such summons shall be served in the Form II or Form IIA or Form IIB or Form IIC, as the case may be. In case of summons to an accused person to be served by police officer, every such summons shall be served in the Form III or Form IIIA or Form IIIB, as the case may be.
- 3. Every summons to a witness shall be served in the Form IB by the presiding officer of the Court (or such other officer as may be directed by the High Court) issuing it. In case of summons to a witness to be served by an executive magistrate, every such summons shall be served in the Form IID. In case of summons to a witness to be served by a police officer, every such summons shall be served in the Form IIIC.
- 4. Every Police Station or the registrar in the Court or Executive Magistrate in the State shall maintain a register in the **Form IV** to record the address, email ID, phone number, and other relevant details of the accused person summoned, another register in the **Form V** to record the address, email ID, phone number, and other relevant details of the witness summoned and yet another register in the **Form VI** to record the address, email ID, phone number, and other relevant details of the any other person summoned.
- 5. The summons bearing the image of the Court's seal or office of the Executive Magistrate's seal or Police Station's seal shall, where practicable, be served personally on the person summoned, by delivering or tendering to him one of the duplicates of the summons. Summons May also be served by electronic communication viz. Email, Whatsapp or any other digital/electronic mode as may be notified by the Government of Arunachal Pradesh).
- 6. Every person on whom a summons is so served personally shall, if so required by the serving officer, sign a receipt therefor on the back of the other duplicate. In case of serving of summons by electronic communication, the proof of delivery of the electronic communication made in the mode specified in Rule (5) shall be treated as proof of receipt of the summons so served. No confirmation of receipt by the person summoned is required in such case.
