DECLARATION

The 9th June, 2025

(Under Section (19) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No.LMD-13011(11)/39/2022/549.— WHEREAS, it appears to the Governor of Arunachal Pradesh that a total of 11.00 Hectare (1,10,000 Sq mtr) of land is required at Mipi Circle, Dibang Valley District for public purpose, namely establishment of additional 10.00 KM-13.00 KM Mipi-Andrela Road Project by 62 RCC, BRTF (GREF) under Mipi Circle, Dibang Valley District.

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide Memo No. LMD-13011(11)/39/2022/1545 dated 28th November, 2024 notifying the intention of the State Government for acquiring of **11.00 Hectare (1,10,000 Sq mtr)** of the said land and inviting public claims and objections to the proposed acquisition of land, if any.

AND WHERAES, the Deputy Commissioner, Dibang Valley District, vide his Memo No.DV/LM-55 (III)/ 2022/6860-67 dated 3rd December, 2024 certified that land is a private land and free from public and Government projects and that there are no project affected families and therefore no compensation towards Rehabilitation and Resettlement are required to be paid under Section 31 of the LARR Act, 2013 and has Requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

AND WHEREAS, the Deputy Commissioner, Dibang Valley District, Anini vide letter No.DV/LM/55(iii)/2023/9775-78, dated 29th February, 2025 submitted for issue of corrigendum to the preliminary notification for the area mentioned at SI. No. 1 to be read as 72,000 sqm instead of 2,40,000 sqm and accordingly corrigendum to the preliminary notification under Section 11 was published vide notifiaction No. LMD-13011(11)/39/2022/2369 dated 18th March, 2025.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters -II and III and Sections -15 and 16 shall not apply to acquisition process in respect of the said land at Basam under Mipi Circle in Dibang Valley District.

AND NOW, therefore, the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land **11.00 Hectare (1,10,000 sq mtr)** located at Mipi Circle, Dibang Valley District is being acquired and the detailed description whereof is as follows:-
