DECLARATION

The 11th July, 2025

(Under Section (19) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013).

No. LMD-13011/27/2024/726.— Whereas, it appears to Governor of Arunachal Pradesh that a total 0.897 acres (3630 Sqmtrs.) of land is required at Rakar Village under Raga Circle, Kamle District for public purposes namely Construction of Approach road for construction of the 33/11 KV Sub-Station at Rakar Village under Comprehensive Scheme for Strengthening of T and D in Arunachal Pradesh under Raga Circle of Kamle District.

AND WHEREAS, a Preliminary Notification as required under Section 11 of LARP Act, 2013 was issued by the Department of Land Management vide Memo No.LMD-13011/27/2024/175 dated Itanagar, the 24th May, 2024, notifying the intention of the State Government for acquiring of 0.897 acres (3630 Sqmtrs.) of the land and inviting public claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Kamle District vide his Memo No.DC/KAM/LM-631/2023 (Vol-I)/2869-73, dated Raga, the 22nd July, 2024 Certified that land is a private land and free from public and Government projects and that there are no project affected families and therefore compensation towards Rehabilitation and Resettlement of public of Village are required to be paid under Section 31 of LARP Act and has requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters-II and III and Section -15 and 16 shall not apply acquisition process in respect of the said land at Rakar for construction of approach road towards the proposed 33/11 kv Raga Sub-station Rakar Village under Comprehensive Scheme for Strengthening of T and D in Arunachal Pradesh under Raga Circle of Kamle District.

AND NOW, therefore, the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act, specifying that the piece of land measuring 0.897 acres (3630 Sqmtrs.) located at Rakar Village under Comprehensive Scheme for Strengthening of T and D in Arunachal Pradesh under Raga Circle of Kamle District is being acquired, the detailed description whereof is as follows :-
