## PRELIMINARY NOTIFICATION

The 11th July, 2025

(Issued under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013).

No. LMD-13011/11/2025/728.— **WHEREAS**, the Power and function of the appropriate authority under the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercise and discharged by him within the State.

**WHEREAS**, the 77 RCC(GREF) has sent a requisition vide No. 2537/B-D/LCB/109.89-112.261/12/E2 dated 2nd April, 2025 for acquisition of land to an extent of 4.40 hectares/10.87 acres/44000 Sqm for improvement of existing single lane road to NH double lane road from km 112.261 to km 114.461 on road Daporijo-New Bridge under RCC/23 BRTF (P) Arunak in Upper Subansiri District of Arunachal Pradesh.

**WHEREAS**, it appears to the Governor of Arunachal Pradesh that land is likely to be needed at the locality more fully described in the schedule below for improvement of existing single lane road to NH double lane road from km 112.261 to km 114.461 on road Daporijo-New Bridge under RCC/23 BRTF(P) Arunak in Upper Subansiri District of Arunachal Pradesh at net area of 4.40 hectares/10/87 acres/44000 Sqmtrs under Daporijo Circle in Upper Subansiri District. It is hereby notified that land in the locality in the schedule below is likely to be acquired for the above said purpose at expense of requiring body. The summary of the social assessment for the locality described in the mentioned schedule is also included below for mentioned purpose.

**WHEREAS**, as intimated by the Deputy Commissioner, Upper Subansiri District, Daporijo that there is no "SIA" is required for this case in view of non-displacement of any affected land owners and the said plot is located at existing road which only for improvement of road from single lane to double lane.

**NOW THEREFORE**, this notification is made under the provision of Section-11(1) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concerned.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section-11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e., Sale/purchase/gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the Collector.

Any person interest in the said land and whomsoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, Upper Subansiri District, Daporijo Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office Daporijo.
