CORRIGENDUM NOTIFICATION

The 2nd June, 2025

(Issued under Section -19 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-12015/1/2021/603.—**WHEREAS**, the powers and functions of the appropriate authority under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vested in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the State.

AND WHEREAS, the Governor of Arunachal Pradesh is satisfied that the land locality or localities more fully described in the schedule below is required for public purpose namely for construction of N.F. Railway Broad Gauge Project. It is hereby declared that land described in the schedule below is likely to be acquired for the above said purpose at the expense of the requiring body.

AND WHEREAS, the Final notification was published vide No. LM - 119/2016 dated 24th February, 2017 for acquisition of an area measuring 11,36,070 Sqms from Leku River 2 - Mile, Pasighat under Sille-Oyan Circle and Pasighat Circle for N.F. Railway Broad Gauge Project.

AND WHEREAS, an addendum notification was published vide No. LMD 12015/1/2021 dated Itanagar 4th May, 2022 for acquisition of an additional area measuring 1,15,,290 Sqmtrs resulting the total area acquired to 1251,360 Sqmtrs.

AND WHEREAS, another addendum notification was published vide No. LMD 12015/1/2021/102 dated Itanagar, 13th September, 2024 for acquisition of an additional area measuring 38400 Sqmtrs due to change in the railway line and for construction of ROB (Road Over Bridge).

AND WHEREAS, as communicated by N.F. Railway authorities vide letter No.W/349/CON/MISCPAGT/32 dated 28th April, 2025, the area to be acquired is to be reduced from 23538.2 Sqmtrs to 7933.40 Sqmtrs due to change in the railway line. However, the area measuring 14861.80 Sqmtrs for ROB (Road Over Bridge) is to remain as such.

AND WHEREAS, the rectified area measuring 22795.2 Sqms {(7933.40 +14861.80) required to be notified for acquisition of the land for the aforesaid N.F Railway Project.

NOW, THEREFORE, this declaration is made under the provisions of Section 19-(1) Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concern.

The Deputy Commissioner, East Siang District, Pasighat, Arunachal Pradesh is hereby directed to take order for the acquisition of the said land as per the provisions of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.
