DECLARATION

The 2nd June, 2025

(Under Section (19) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/62/2024/448.—**WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total area of land 4740.00 Sqm is required for construction of bridges at KM 25.750 with 35M Span PSC Box Girder bridge, at KM 35.970 with 21M Span T. Beam RCC PMT ridge and at KM 36.060 with 50M Span PSC Box Girder bride by 1441 BCC (BRTF) in Shakti Village under Zemeithang Circle, Tawang District for public purposes only.

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide Memo No. LMD-13011/62/2024/1529 dated 26th November, 2024 notifying the intention of the State Government for acquiring of 4740.00 Sqm inviting claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Tawang District, vide his Memo No. TLR-70/2016-17/5515-17 dated 22nd October, 2024 certified that the land is a community land and free from public and Government projects and that there is no project affected families and therefore no compensation towards Rehabilitation and Resettlement are required to be paid under Section 31 of the LARR Act, 2013 and has requested that State Government to issue the declaration under Section 19 of LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters - II and III and Section -15 and 16 shall not apply to acquisition process in respect of the said land No. LMD-13011/62/2024/1529 dated 26th November, 2024 under Zemeithang Circle by BRTF.

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring 1684.09.00 Sqm located construction of bridges at KM 25.750 with 35M Span PSC Box Girder bridge, at KM 35.970 with 21M Span T. Beam RCC PMT ridge and at KM 36.060 with 50M Span PSC Box Girder bride by 1441 BCC (BRTF) in BTK Village under Zemeithang Circle, Tawang District is being acquired and the detailed description whereof is as follows :
