## CORRIGENDUM NOTIFICATION

The 2nd June, 2025

No. LMD-13011(11)/46/2022/422.—**WHEREAS**, a notification under Section-10 of Jhum Land Regulation, 1947 was issued vide Memo No.LM-84/2012/9406 dated 7th November, 2012 for acquisition of land for construction of B-C-T Road (Khrimu to Nehru Market) and (IV Bridge to Lhou) in Tawang Circle, Tawang District for public purpose.

**WHEREAS**, the road stretches viz. IV Bridge to Lhou and Khrimu to Nehru Market required to be processes through IRC: SP: 48-1998 taking road width of 18 meters instead of 24 meters width. Description of the said stretch of roads are as under.

**WHEREAS**, few Government land and structures were found falling within the road length from Khrimu to Nehru Market (KM 299.00 to KM 316.843) of B-C-T Road and resultantly there is a reduction in area to 114955.08 sqm from 147300 sqm due to exclusion of the concerned areas.

**AND WHEREAS**, the Deputy Commissioner, Tawang District, Tawang vide his letter No. TLM-70/2016-17 dated 21st May, 2025 forwarded a draft corrigendum for publication in the Arunachal Pradesh Gazette and local newspapers for rectification of the area measuring 147300 sqm to 114955.08 sqm under B-C-T Road from Khrimu to Nehru Market (KM 299.00 to KM 316.843) falling under Tawang District.

**THEREFORE**, this corrigendum notification is issued in continuation of the earliar Notification issued vide No.LM-84/2012/9406 dated 7th November, 2012.

All other contents of the Notification shall remain unchanged.
