DRAFT PRELIMINARY NOTIFICATION

The 20th June, 2025

(Issued under Section 10 of Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation Ammendment Act, 2024)

No. LMD-13011/1/2021/583.—**WHEREAS**, the power to acquire land is vested with the Government of Arunachal Pradesh and it is the competence of the Governor to notify any land within the State of Arunachal Pradesh for public under Section 10 of Jhum Land Regulation, 1947.

WHEREAS, the Executive Director (DMP), NHPC Roing, vide letter NH/DMP/HOP/2023/893 dated 30th January, 2023 has requested to expedite the process of land acquisition for an area measuring 17.62 ha on Right Bank for Construction of Dam Structure and has requested Deputy Commissioner-cum-District Collector Roing to acquire land at Dambuk.

AND WHEREAS, under Section 10 of Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amendment) Act, 2024, Government may acquire any Jhum Land required for public purpose without formal acquisition proceedings by giving an opportunity to those having rights in the land and after payment of a reasonable compensation so determined by the Government which shall not be less than the amount computed under the provisions of extant law i.e. the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for the time being in force.

NOW, THEREFORE, the Governor of Arunachal Pradesh do hereby declare that the land described in the Schedule below is hereby notified for the mentioned purpose under Section 10 of the Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amendment) Act, 2024 for the construction of **Dibang Multipurpose Project (2880 MW).**

Any person who has any objection to the acquisition of land may file such objection in writing to the office of Deputy Commissioner, Lower Dibang Valley within 30 (thirty) days from the publication of this notification clearly stating the reason from such objection and the Deputy Commissioner, in her capacity shall dispose of the same, after giving reasonable opportunity of hearing to extinguish the claim of the Land owners.

The Deputy Commissioner, Lower Dibang Valley District Roing shall take possession of the above-mentioned land for the said purpose after tendering payment of compensation to the land owners/persons interested.

The map and plan may be inspected in the office of District Land Revenue and Settlement Officer Lower Dibang Valley District Roing during office hours.
