DECLARATION

The 1st May, 2025

(Under Section (19) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(13)/106/2024— **WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total **24.3414 Hectares (2,43,414 Sqmtrs)** of land is required at Konnu and Konsa Villages under **Pongchau Circle, Longding District** for public purposes namely **Construction of approach roads and HSS fencing at BP-157 along the Indo-Myanmar border.**

AND WHEREAS, a preliminary notification as required under Section 11 of LARR Act, 2013 was issued by the Department of Land Management vide Memo No. **LMD-13011(13)/106/2024/3048 dated 11th November, 2024** notifying that intention of the State Government for acquiring of **24.3414 Hectares (2,43,414 Sqmtrs)** of the land and inviting public claims and objections to the proposed acquisition of land if any.

AND WHEREAS, the Deputy Commissioner, Longding District, vide his Memo No. LDG/LM/GREF-1(Vol-III)/2024/8718-19 dated 8th October, 2024 certified that land is a private land and is free from public and Government projects and that there are no project affected families and therefore no compensation towards Rehabilitation and Resettlement for Konnu and Konsa Villages at Pongchau Circle (C/o-approach road and HSS fencing) are required to be paid under Section 31 of the LARR Act and has requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

AND WHEREAS, the Appropriate Government is pleased to note that it is satisfied that Chapters-II and III and Section-15 and 16 shall not apply to acquisition process in respect of the said land at Konnu and Konsa Villages of Pongchau Circle for construction of approach road and HSS fencing along the Indo-Myanmar border.

AND NOW, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act, specifying that the piece of land measuring **24.3414 Hectares (2,43,414 Sqm)** located at **Konnu and Konsa Villages under Pongchau Circle, Longding District** is being acquired, the detailed description whereof is as follows :-
