NOTIFICATION

No. Home-12047/6/2022.—In pursuance of Rule 19 of the Narcotic Drugs and Psychotropic Substances (Seizure, Storage, Sampling and Disposal) Rules, 2022, and in supersession of Notification No. HOME-12047/6/2022, dated 23rd August, 2022, the Governor of Arunachal Pradesh is pleased to constitute the following Drug Disposal Committees:

A. District-Level Drug Disposal Committee :

(i) Superintendent of Police of the District — Chairman
 (ii) Superintendent (Tax, Excise and Narcotics) of the District — Member
 (iii) Representative of the NCB, Itanagar Zonal Unit — Member

B. High-Level Drug Disposal Committee :

(i) IGP/DIGP of the concerned Range — Chairman
 (ii) Superintendent of Police of the District — Member
 (iii) Deputy Secretary/Joint Secretary (Home), GoAP — Member
 (iv) Superintendent (Tax, Excise and Narcotics) of the District — Member

2. The Drug Disposal Committee shall:

- (a) Meet as frequently as possible and necessary;
- (b) Conduct a detailed review of seized items pending disposal;
- (c) Order the disposal of seized items; and
- (d) Advise the respective investigating or supervisory officers on steps for expeditious disposal.

3. The District - Level Drug Disposal Committe is empowered to order the disposal of seized materials up to the quantity or value specified in the table below :

| SI. No. | Name of Item | Quantity per consignment |
|---------|---|--|
| 1 | 2 | 3 |
| 1. | Heroin | 5 Kilogram |
| 2. | Hashish (Charas) | 100 Kilogram |
| 3. | Hashish oil | 20 Kilogram |
| 4. | Ganja | 1000 Kilogram |
| 5. | Cocaine | 2 Kilogram |
| 6. | Mandrax | 3000 Kilogram |
| 7. | Poppy straw | Up to 10 Metric Tonne |
| 8. | Other Narcotic Drugs, psychotropic substances, or controlled substances | Upto a quantity of 500 Kilogram or 500 Litre |
| 9. | Conveyaces | Upto a value of ₹ 50 Lakh |

Note: For the disposal of consignments exceeding the above limits, the District-Level Drug Disposal Committee shall forward its recommendations to the concerned High-Level Drug Disposal Committee for appropriate Action.

4. This is issued with the Approval of the Competent Authority.
