PRELIMINARY NOTIFICATION

The 14th May, 2025

Issued under Section 11(1) Read with Section 40 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (invoking Urgency clause)

No. LMD-13011(11)/19/2022/296.—**WHEREAS**, it appears to the Governor that a total of 1.60 Hectares of land is required at Pango Village under Migging Circle in Upper Siang District for acquisition of land for additional Muck Disposal site from Ch. 0+00 KM to 9+00 KM for C/o Pango-Jorging Intermediate Road by NHIDCL..

A total No. of Nil families are likely to be displaced due to the land acquisition. The reason necessitating such as given below.

Therefore, it is notified that for the above said project in the Pango to Jorging Village under Migging Circle, Upper Siang District, a piece of land measuring 1.60 Hectares (16000 sqm) of standard measurement, whose details description is as follows, is under proposal of acquisition.

This Notification is made under the provision of Section 40 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

This refers to National Highways and Infrastructure Development Corporation Ltd., Ministry of Road Transport and Highways, Government of India's letter No. NHIDCL/RO-ITA/02/DPR/FH/P-J/2023-24/6575 dated 18th September, 2023.

A plan of the land may be inspected in the office of the Deputy Commissioner/Collector and DLRSO, Yingkiong on any working day during the working hours.

The Governor is please to authorized Deputy Commissioner, Upper Siang District/NHIDCL and their staff to enter upon and survey land take level of any land dig or bore into the sub - soil and do all other acts required for the proper execution of their work as provided and specified in Section 12 of the said Act.

Under Section 11 (4) of the Acts, no person shall make any transaction of cause any transaction of land i.e.,sale/purchase, etc. or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.

The Provisions of sub-sections (1), (2) and sub-section (3) of Section 40(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 are applicable to the acquisition of the aforesaid land.

The Provisions of Chapters - II and III and Section 15 to 18 of the Act shall not apply to the Acquisition and declaration may be made under Section 19 in respect of the above land at any time after the date of publication of the Preliminary Notification under sub-section (1) of Section 11 ;

The Collector (Deputy Commissioner), Upper Siang District, Arunachal Pradesh, though no award has been, may, on expiration of thirty days from the publication of the notice mentioned in Section 21, take possession of any land needed for the public purpose and such land shall thereupon vest absolutely in the Government, free from all encumbrances ; and.

No additional compensation will be required to be paid for acquisition of the above land.

Since, the land is urgently required for the project falling within the purview of Section 40 (4), it has been decided not to carry out the Social Impact Assessment Study.
