Subject : Revision of Rate of Dearness Allowances to Government Employees-effective from 1st January, 2024.

No. ESTT-II-14/3/2022-ESTT-II-FPID/05.—In pursuance to the Government of India, Ministry of Finance, Department of Expenditure OM. No. 1/1/2024-E-II(B), dated 12th March, 2024 (copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Allowance (DA) payable to State Government Employees shall be enhanced by 4% from the existing rate of 46% to 50% of the Basic Pay with effect **from 1st January, 2024. The DA arrears for the period from 1st January, 2024 to 31st March, 2024 shall be paid in cash.**

The term Basic Pay in the revised pay structure means the pay drawn in the prescribed level in the Pay Matrix as per 7th CPC recommendations accepted by the Government, but does not include any other type of Pay like special pay etc.

The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9(21).

The expenditure on account of this Dearness Allowance shall be met from existing Budget provisions of the Department concerned in the Current Financial Year 2024-25.

The revised rates of Dearness Allowance shall be applicable to regular State Government employees only and shall not apply to private /Non-Governmental institutions receiving Grants-in-Aids from the State Government.
