#### **NOTIFICATION**

The 25th April, 2024

No. AR-114/2023-SECT-4-AR/126.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the Recruitment to the posts of Senior Personal Assistant (Arunachal Pradesh Stenographer Grade - II Service) (Common) Rules, 2015 Namely:—

- 1. Short title and commencement: (i) These rules may be called "The Senior Personal Assistant (Arunachal Pradesh Stenographer Grade II Service) (Common) Recruitment (Ammendent) Rules, 2024".
  - (ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
- Amendment of the Schedule : In the Scheule I of the Principal Rule notified vide No. AR-76/2013(B) dated 1st April, 2015 hereinafter referred to as Principal Rules:—
  - (i) In Column 5, for the existing entries, the following entries shall be substituted, namely "Selection".
  - (ii) In Column 6, for the existing entries, the following entries shall be substituted, namely :-

"Between 18 and 35 years of age with 5 years relaxation to the candidate(s) belonging to Arunachal Pradesh Schedule Tribe in terms of Government Notification No. AR/219/2022-US-1-AR dated 25th February, 2023 as amended from time to time".

- (iii) In Column 7, for the existing entries, the following entries shall be substituted, namely :-
  - "1. Educational Qualification: Graduation/Bachelor Degree in any discipline from a recognized

University.

- 2. Stenography (English) : Speed of 100 Words Per Minute".
- (iv) In Column 8, for the existing entries, the following entries shall be substituted, namely :-

"(1) Age : No.

- (ii) Educational Qualification: Yes. As Prescribed in column 7".
- (v) In Column 10, for the existing entries, the following entries shall be substituted, namely :-
  - "(1) 40% By Promotion (Seniority Quota) as prescribed at Column 11.
  - (2) 40% By Limited Departmental Competitive Examination (LDCE) through merit from amongst the Personal Assistant of the Arunachal Pradesh Stenographers Service (General Cadre) who have rendered **6 (six) years of regular service** in the Steno-Grade-III (PA) and drawing pay in the Pay Matrix Level 5 ₹ 29,200-92,300 p.m. and qualify the minimum speed in the Stenography Proficiency Test as specified at Column 10 (3) (A) (1).
  - (3) 20% By Direct Recruitment through merit adjudged on the basis of the Recruitment Test conducted by the APPSC as per the following scheme of examination.

#### A. SCHEME OF EXAMINATION:

The Scheme for selection of Candidates for recruitment to the post of Stenographer Grade - II/SPA will comprise of the following two parts :-

## (1) STENOGRAPHY PROFICIENCY TEST (ENGLISH)

- (a) Dictation (English) : Stenographer Proficiency Test will be conducted for 5 minutes at the speed of 100 Words per Minutes (WPM).
- (b) Transcription: 60 minutes (English), Skill Test shall be done on Computer. An average of 5 Key Depression for each word.
- (c) Following Permissible mistakes in transcription would apply in Speed Test in respect of candidates belonging to :-
- (i) For candidate(s) belonging to General Category 8%.
- (ii) For candidate(s) belonging to APST Category 10%
- **NB**: There will be a trial passage and another test Passage selected beforehand.
  - (a) The trial passage will be dictated by the same person or through Audio/Video device so that the candidate can get familiar with his /its mode of dictation and accents of pronounciation. The Trial passage will be dictated twice at the same speed as for the test passage, with an interval of one minute in between.
  - (b) The minimum qualifying marks shall be as fixed by the Arunachal Pradesh Public Service Commission at their discretion.

## (2) OBJECTIVE TYPE WRITTEN TEST

The candidates qualifying in the Stenography Proficiency Test as specified at Column 10 (3) A (1) shall be called for Objective Type Written Test. The Objective Type Test shall be on the following subjects:

	Total	240 Marks
(c)	Viva-Voce	40 Marks
(b)	General Knowledge	100 Marks
(a)	General English	100 Marks

The Syllabus/Objective Type Questions and duration of the examination shall be decided by the Arunachal Pradesh Public Service Commission.

NB: (i) Marks in Stenography Proficiency Test will not be added to the aggregate and it will be Qualifying Test only. The names of the candidates shall be arranged on the basis of marks obtained by the candidates in objective Type Written Test only."

vi. In column 11, for the existing entries, the following entries shall be substituted, namely :-

"Promotion (Seniority quota): Personal Assistant of the Arunachal Pradesh Stenographers Service (General Cadre) drawing pay in the Pay Matrix Level -  $5 \stackrel{?}{=} 29,200-92,300$  PM with 6 (six) years of regular service in the grade".

No. AR-11011/14/2021-US-1-AR.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend "The General Arunachal Service, Group - 'C' Driver, Non-Gazetted, Non-Ministerial, Common Recruitment Rules, 2006 in various Departments under the Government of Arunachal Pradesh, Namely:-

#### 1. Short title and commencement :

(1) These rules may be called "The General Arunachal Service, Group - 'C' Driver, Non-Gazetted, Non-Ministerial, Common Recruitment (Amendment) Rules, 2024."

- (2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
- 2. Amendment to the Schedule of the Principal Rules:

In the schedule: (i) For the entries in column 10, the following entries shall be substituted:-

- (a) 50% by Direct Recruitment conducted by APSSB;
- (b) 25% of the vacancies through Limited Departmental Competitive Examination (LDCE) conducted by the APSSB from amongst the Contingency Skilled Driver who possess Class X/ITI or equivalent pass Certificate from a recognized Board or Institution with 10 years of service in the concerned Department/Office.
- (c) 25% of the vacancies through Limited Departmental Competitive Examination (LDCE) conducted by the APSSB from amongst the Handyman who possess Class X/ITI or equivalent pass Certificate from a recognized Board or Institution with 6 (six) years of regular service in the concerned Department/Office.

The Examination Scheme for Direct Recruitment and Limited Departmental Competitive Examination shall be in accordance with the Government Notification Omnibus Rules No. 27012/2/2022-SECTT-1-AR dated 14th August, 2023, as amended from time to time.

- (ii) For the entries in column 11, the following entries shall be substituted : Remaining 50% by the following manner:-
  - (i) 25% of vacancies shall be filled from the Contingency Skilled Driver of the Concerned Department/Office with minimum 10 years of continuous service as Contingency Skilled Driver and possessing educational and other qualifications as prescribed in column 7 through LDCE as prescribed in Column 10 above.
  - (ii) 25% of vacancies shall be filled from amongst the Handyman in the Pay Matrix Level 1 ₹ 18,000-56,900 p.m. of the Concerned Department/Office with minimum 6 (six) years of regular service in the grade of Handyman with educational and other qualifications as prescribed in column 7 through LDCE as prescribed at Column 10 above.

Note Below (ii): In the event of non-availability of eligible Handyman, the vacancies to the extent available shall be filled up by Direct Recruitment.
