No. LMD-13011/7/2024/413.—**WHEREAS**, the power and function of the appropriate authority under the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest with the Governor of Arunachal Pradesh which shall be exercise and discharged by him within the State.

WHEREAS, the Requiring Body, 120 RCC (BRTF), has sent a requisition vide letter No. Nil dated 24th April, 2023 for acquisition of land to an extent of 1376400.00 Sqm and 42838.00 Sqm for the construction of broder road from Damteng-Selungthi-Lungar-Chuna and Muck Dumping area in Mago Village.

WHEREAS, it appears to the Governor of Arunachal Pradesh that the land is likely to be needed at the locality more fully described in the schedule below for the construction of broder road for an area measuring 1376400.00 Sqm and 42838.00 Sqm located at Damteng-Selungthi-Lungar-Chuna and Muck Dumping area in Mago Village under Thingbu Circle in Tawang District, Arunachal Pradesh. It is hereby notified that land in the locality/localities in the schedule below is likely to be acquired for the above said purpose at expense of requiring body. **Further, the Deputy Commissioner, Tawang District, Tawang vide his letter No. TLR-70/2013-14 dated 9th January, 2024 has informed that there are no habitations nearby, therefore there will be no adverse social impact as a result of acquisition of this land by BRTF and also the number of families likely to be resettled due to the proposed land acquisition is nil and as such publication of summary of the Rehabilitation and Resettlement scheme is not required.**

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act,

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale/purchase/gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the collector.

Any person interest in the said land and whomsoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section - 15 of the Act, file such objection in writing before the Deputy Commissioner, Tawang District, Tawang, Arunachal Pradesh.

(2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
- These rules shall apply to the posts as specified in column 1 of the Schedule I and II annexed to this Rules.**
- Number of posts, Classification and Scale of Pay Matrix :** The number of posts, their classification and the level in Pay Matrix attached thereto shall be as specified in columns 2 to 4 in the schedule aforesaid.
- Method of Recruitment, Age limit and other Qualifications etc. :** The method of recruitment to the said posts, age limit, educational qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the Schedule aforesaid.
- Disqualifications :** No person,-
 - who has entered into or contracted a marriage with a person having a spouse living ; or
 - who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post.

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of these rules.

- Power to relax :** Where the Governor of Arunachal Pradesh is of opinion that, it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing and in observing the procedures as prescribed under OM No. AR-89/2012 dated 6th March, 2013 and in consultation with the Commission relax any of the provisions of these rules with respect to any class or category of persons.
- Repeal and Saving :** All rules and procedure corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validity made or taken under the corresponding provisions of these Rules.

Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to be provided for Arunachal Pradesh Scheduled Tribes and other special categories of person in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.
