No. AR/85/2024-SECT-1-AR/465.—In the Office Memorandum No. AR-74/2013/Vol -II dated 29th August, 2019, issued regarding reintroduction of “Fixation of Graduation/Bachelor Degree as Basic Educational Qualification for appointment in Group - ‘A’ and Group - ‘B’ posts/Services wherein minor mistake has occurred which are corrected as below :

1. For the words appeared as - “Now therefore, the Governor of Arunachal Pradesh is pleased to reintroduce the Fixation of the minimum educational qualification of Graduation/Bachelor Degree from a recognized University for considering appointment to Group ‘A’ and ‘B’ posts/Services either by direct Recruitment or promotion with effect from the date of issue of this office Memorandum except the Diploma holders like engineering, Architecture, Nursing, Tourism, Hotel Management and Catering Technology, Applied Arts and Crafts and Draughtsman are exempted from the purview and operation of this Office Memorandum”, in the Para - 6 of the Office Memorandum may be read as under :

“Now, therefore, the Governor of Arunachal Pradesh is pleased to reintroduce the Fixation of the minimum educational qualification of Graduation/Bachelor Degree from a recognized University for considering appointment to Group ‘A’ and ‘B’ posts/Services either by direct recruitment or promotion with effect from the date of issue of this Office Memorandum.

Provided that, subject to the provisions prescribed in the Recruitment Rules, the minimum educational qualification of Graduation/Bachelor Degree from a recognized University will not be applicable in the case(s) of Group - ‘A’ posts which are filled up by promotion from holders of Diploma in Engineering, Architecture, Nursing, Tourism, Hotel Management and Catering Technology, Applied Arts and Crafts and Draughtsman which are exempted from the purview and operation of this Office Memorandum.

Provided further that, subject to the provisions prescribed in the Recruitment Rules, the minimum educational qualification of Graduation/Bachelor Degree from a recognized University will not be applicable in case of Group - ‘B’ posts which are filled up either by Direct Recruitment or by Promotion from the holders of Diploma in Engineering, Architecture, Nursing, Tourism, Hotel Management and Catering Technology, Applied Arts and Crafts and Draughtsman which are exempted from the purview and operation of this Office Memorandum.”

All public service Vehicles and registered in the state of Arunachal Pradesh except two-wheelers, e-rickshaw, three-wheelers and any transport Vehicles for which permit is not required under the Motor Vehicle Act, 1988, shall be equipped with or fitted with Vehicle Location Tracking (VLT) device and one or more emergency buttons at conspicuous position.

2. The Vehicle Location Tracking (VLT) device and emergency button shall be fitted by the manufacture or their dealer or the respective operator in accordance with AIS-140 : 2016 as amended from time to time, till such time the corresponding BIS specification are notified under the Bureau of Indian Standard Act, 1986.

The VLT device manufacturer will have to get their devices tested and certified from the testing agencies referred to in rule 126 of the Central Motor Vehicle Rules, 1989 for compliance of rule 125H of said Rules. All such devices should be connected and configured with the monitoring centre set up by the State Government under Nirbhaya framework or any other similar back end software of the State Government of Vehicles Location Tracking.
4. The Standard Operating Procedure (SOP) for Vehicle Location Tracking Device registration and activation in VAHAN issued vide No. RT-16011/7/2020-T dated 22nd February, 2021 by Ministry of Road Transport and Highways, Government of India shall be followed.

- Power to relax :** Where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class of category of person.
- Saving :** Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to provide for Arunachal Pradesh Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.
- This notification shall supersede earlier notification issued vide number EED. 3/BLT/13/2012-13 Pt, dated 11th November, 2014 under which 36 MILT (Bhoti Language) teachers got regularized. The said notification shall deem to be merged with the instant notification thereof.

1. **Nursing Superintendent, Assistant Nursing Superintendent and Senior Nursing Officer)** :-While Gale with half/full White Apron and Badge with full name and designation, RNRM Number, Black shoes and Black Sweater.
2. **Nursing Officer (NO)** :- White Surgical Scrub, with full/half white Apron, black shoes, black swearter and hair tie tidy with black net, Badge with full name and designation, RNRM number.
3. **Operation Theatre** :- Green Colour surgical scrub dress, hair tie tidy under surgical cap, Badge with full name and designation, RNRM number.
4. **Labour Room** :- Light Blue Colour scrub dress with hair tie tidy with black net. Badge with full name and designation, RNRM number.
5. **Tutor/LHV/ANM:- No. Change as describe below;**

(a) **Tutor** :- Light Pink Saree with Pink blouse, long sleeve white Apron, Badge with full name and designation and RNRM number, Black Shoe, Black Sweater, (Hair tie tidy with black net when in clinical duty) and newly created posts like Principal, Associate Professor, Assistant Professor also shall follow the same as Tutor.

(b) **LHV/ANM**:-White plain Gale, half sleeve white Apron, Black sweater, black shoe and badge with full name and designation with RNRM number, hair tie tidy with black net.
