No. 9(4)/2012-PD-II dated 20th March, 2015 and in pursuance of the objective of the Government to improve the viability of Fair Price Shop operation, the Governor of Arunachal Pradesh is pleased to amend sub clause (8) of clause 9 of the Notification No. DFCS/MON/CO/2015 dated 27th October 2016, as under:-

#### 1. Nursing Administration:

(Nursing Superintendent, Assistant Nursing Superintendent and Senior Nursing Officer).

White Gale in Green border with half/full White Apron and Badge with full name and designation, RNRM Number, Black Shoes and Black Sweater.

# 2. Nursing Officer (NO):

White Surgical Scrub, with full/half White Apron, black shoes, black sweater and hair tie tidy with black net, Badge with full name and designation, RNRM Number.

- 3. **Operation Theatre:** Green Colour Surgical Scrub Dress, hair tie tidy under surgical cap, Badge with full name and designation, RNRM Number.
- 4. **Labour Room**: Light Blue Colour Scrub Dress with hair tie tidy with black net. Badge with full name and designation, RNRM Number.
- 5. **SNCU/ICU Ward**: Light Pink Colour Scrub Dress with hair tie with black net. Badge with full name and designation, RNRM Number.

# 6. Tutor/LHV/ANM: No Change as describe below;

- (a) **Tutor:** Light Pink Saree/Gale, White tops with White Apron, Badge with full name and designation and RNRM Number, Black Shoe, Black Sweater. (Hair tie tidy with black net when in clinical duty) and newly created posts like Principal, Associate Professor, Assistant Professor also shall follow the same as Tutor.
- (b) **LHV/ANM**: White Gale without Border, half sleeve White Apron, Black Sweater, black shoe and badge with full name and designation with RNRM Number, hair tie tidy with black net.
- 7. No Nurses shall put Uniform from Home to Hospital and vice-versa. Uniform must be donned and doffed within the Hospital premises to ensure the highest standards of hygiene and to prevent potential contamination.
- 8. Those Hospital or any Government Healthcare facilities wearing different Uniform other than Government approved shall be viewed seriously and debarred from Uniform Allowance.
- 9. Failure to adhere to this notification may result in disciplinary action as per the policies.
- 10. No Uniform Code for Nursing Officers in Directorate level and Nursing council office during office hour but they will be in Uniform when they go to field visit/inspection etc. with half sleeves/long sleeves white apron and badge as stated above.
