- 3. **Number of posts, classification and scale of Pay Matrix**: The number of posts, their classification and the level in Pay Matrix attached thereto shall be as specified in columns 2 to 4 in the schedule aforesaid.
- 4. **Method of Recruitment, age limit and other qualifications etc.**: The method of recruitment to the said posts, age limit, educational qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the Schedule aforesaid.
- 5. Disqualifications: No person,-
 - (i) who has entered into or contracted a marriage with a person having a spouse living; or
 - (ii) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post.

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of these rules.

- 6. **Power to relax:** Where the Governor of Arunachal Pradesh is of opinion that, it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing and in observing the procedures as prescribed under OM No. AR-89/2012 dated 6th March, 2013 and in consultation with the Board relax any of the provisions of these rules with respect to any class or category of persons.
- 7. **Repeal and Saving:** All rules and procedure corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validity made or taken under the corresponding provisions of these Rules.

Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to be provided for Arunachal Pradesh Scheduled Tribes and other special categories of person in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.
