No. PWRS/75/2022/479-484.—In the Junior Engineer (Power) recruitment rule 2023, notified vide order No. PWRS/E-75/2022 dated 3rd January, 2024, wherein under the title **Syllabus for the Junior Engineer (Power) in the Annexure "A"**, the scheme of the examination specifying subject-wise allotment of marks, Time allotted for written examinations and also the Electrical Engineering subject syllabus distribution in two parts under part-I and part-II are missing/omitted in the content.

Therefore, the following amendment/correction is hereby made, and the corrected contents shall form the part of **Annexure 'A"** of the Examination Scheme and the Electrical Engineering syllabus. The Annexure- "A" of the Junior Engineer (Power) recruitment rule 2023 may be read as below;

Annexure - A

# "Examination Scheme and Syllabus for the recruitment to the post of the Junior Engineer (Power) under Department of Power.

The examination shall be conducted according to the following plan:

**Part A:** The written examination will comprise of two sections: Section - I, consisting of General English including essay writing or letter writing and objective type questions in General knowledge, and Section-II: Technical papers covering the entire syllabus of relevant Diploma Engineering discipline Viz. Electrical, Mechanical, Electronics and Telecommunication, Computer Science/Information Technology.

**Part B :** Personality/Viva-voce test carrying maximum 40 Marks. Such tests will be conducted on the candidates who qualify the written examination.

2. The Following will be the subjects, mark distribution and Time allotted for the written examination:

#### I. Electrical Engineering

#### Part - I

**Basic concepts:** Concepts of resistance, inductance, capacitance and various factors affecting them. Concepts of current, voltage, power, energy and their units.

Circuit law: Kirchhoffs law, Simple Circuit solution using network theorems.

**Magnetic Circuit:** Concepts of flux, mmf, reluctance, Different kinds of magnetic materials, Magnetic calculations for conductors of different configuration e.g. straight, circular, solenoidal, etc., Electromagnetic induction, self and mutual induction. AC.

**Estimation and costing:** Estimation of lighting scheme, electric installation of machines and relevant IE rules. Earthing practices and IE Rules.

Utilization of Electrical Energy: Illumination, Electric, heating, Electric welding, Electroplating.

**Basic Electronic:** Working of various electronic device e.g. PN Junction diodes, Transistors (NPN and PNP type), BJT and SCR. Simple circuits using these devices. Brief idea about universal logic gates".

- 1. **Short title and commencement:** (1) These rules may be called the Minimum Qualifying Marks for Recruitment to Group A, B, and C posts and Common Examination Scheme (for Group-C Posts) (1st Amendment) Rules, 2024.
  - (2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
- 2. Amendment of Rule: In the Principal Rules, in rule 4, in clause (a) in the proviso, for the existing entries, the entries, "Provided that, the candidates belonging to the Arunachal Pradesh Scheduled Tribes or Person with Benchmark Disability (PwBD candidates) or Ex-Servicemen (ESM) Candidates may be recommended for appointment by the Arunachal Pradesh Staff Selection Board by applying relaxed standards, if the Board is of the opinion that sufficient number of candidates belonging to these categories are not likely to be qualified on the basis of the General standard fixed by the Board in order to fill up the vacancies reserved for them" shall be substituted.

- 2. **Amendment of Sub-rule 3 and 4 of Rule 5 of the Principal Rules**: In Sub-Rule 3 and 4 of Rule 5 of the Principal Rules, for the existing entries, to following entries shall be substituted:
  - "(3) The vacancies furnished by the Requisitioning Authority for Direct Recruitment shall exclude the Sport quotas and quota for Compassionate Appointment".
  - "(4) The Board shall be involved in the recruitment process of Meritorious Sports Person under Sports Quota in accordance with the Government of Arunachal Pradesh vide Office Memorandum No. AR-143/2018 dated 20th November, 2022 as amended from time to time.

Further, the Board shall be involved in other recruitment as per Office Memorandum issued by the Government of Arunachal Pradesh from time to time".
