The 30th November, 2024

No. SUDH-11/4/2023-US-UDH/638.—**WHEREAS,** Shri Hano Takka, Joint Director, Information Technology and Communication (IT and C) drawing the substantive scale of pay Level -12 at Pay Matrix of ₹78,800-2,09,200 pm. was posted as Director Urban Local Bodies (ULBS) vide Order No. SUDH- 11/4/2023-US-UDH-UDH dated 28th February, 2023 in the scale of Pay Level - 13 of Pay Matrix of ₹1,23,100-2, 15,900 pm.

**AND WHEREAS,** in pursuance of the aforesaid Order dated 28th February, 2023 Shri Hano Takka submitted his joining report to the Commissioner (ULBs) vide his joining letter dated 6th March, 2023.

**AND WHEREAS**, it has been clarified by the Personnel Department that as such no post of Director (ULB) was ever created and accordingly no such post exist. The Personnel Department has further clarified that the earlier postings of APCS cadre officers as Director (ULB) were administrative arrangements and the APCS being an organized service with specific cadre strength there was no issue in releasing the pay of the APCS officers, in their own substantive pay scales, while they were posted as Director – ULB.

**AND WHEREAS,** in absence of any post of Director, ULB, the salary of Shri Hano Takka could not be drawn against the said post and resultantly he is not getting any salary since his joining as Director (ULB).

**AND WHEREAS,** in absence of any such post the posting of Shri Hano Takka, as Director (ULB) is clearly an administrative arrangement in the nature of diverted capacity and it cannot be interpreted or construed as promotion/deputation/absorption etc. Since the post of Director (ULB) never ever created/existed, the process of Departmental Promotion Committee (DPC)/Selection Committee was also not followed at the time of posting of Shri Hano Takka.

**AND WHEREAS**, in case of such administrative arrangement within the same Government, on transfer from one Department to another Department, the officer cannot be allowed to draw the pay in higher pay scale. He can draw the pay in his own pay scale, either from the same post or from the other post, as the case may be.

**AND WHEREAS,** the parent cadre of Shri Hano Takka remains the same i.e. IT and C and his substantive post remains the same i.e. Joint Director IT and C. Hence the officer should have been allowed to continue drawing his pay in his own pay scale, from the parent department against his substantive post while working as Director-ULB in diverted capacity.

**AND WHEREAS**, the present status of Shri Hano Takka continues to be Joint Director IT and C presently working as Director (ULB), in diverted capacity.

**AND WHEREAS,** on account of non existence of the post of Director (ULB), the initial order dated 28th February, 2023 was irregular to the extent that salary could not be drawn against the post of Director (ULB) and that too in a higher pay scale.

**NOW THEREFORE,** in partial modification of the earlier order dated 28th February, 2023, the appointment of Shri Hano Takka, Joint Director IIT and C) as Director (ULB) would be construed as a posting in diverted capacity. He shall continue to draw his salary in his own substantive pay scale from his parent department IT and C while holding the position of Director ULB in diverted capacity. Further Shri Hano Takka may continue to hold lien and seniority in the cadre of Joint Director (IT and C) for all purposes.
