- 4. **Method of Recruitment, age limit and other qualifications :** The method of recruitment to said post, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 13 of the Schedule attached to these rules.
- 5. Disqualification: No person:
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment in the said post.

Provided that the Governor of Arunachal Pradesh may, is satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these rules.

- 6. **Power to relax:** Where the Governor of Arunachal Pradesh is of the opinion that if it is necessary or expedient so to do, it may, by order for reasons to be recorded in writting and in consultation with the Arunachal Pradesh Staff Selection Board (APSSB), ralax any of the provisions of these rules with respect to any class or category of person or posts and after following the procedure as laid down in Government OM No. AR-89/2012/599 dated 6th March, 2013.

- 1. **Short title and commencement :** (i) These rules may be called "General Arunachal Service, Assistant Audit Officer, Group-B Gazetted, Non-Ministerial (Amendment) Recruitment Rules, 2024"
 - (ii) They shall come into force on the date of their publication in Arunachal Pradesh Gazette.

2. Amendment to the Schedule:

In the Schedule of the principal Recruitment Rules, 2018 of the Assistant Audit Officer, Group-B, Gazetted, Non-Ministerial notified vide Notification No. DAP/SFAS/ESTT-24/2006(Pt.) dated 27th November, 2018, the following enries shall be substituted, namely:

- (i) For the existing entries in Column 5, the entry, "Selection" shall be substituted.
- (ii) For the entries in Column 6, the entries, "Not applicable" shall be substituted.
- (iii) For the entries in Column 7, the entries, "Not applicable" shall be substituted.
- (iv) For the entries in Column 9, the entries, "Not applicable" shall be substituted.
- (v) For the entries in Column 10, the entries, "100% by promotion failing which by transfer on Deputation" shall be substituted.
- (vi) For the entries in Column 11, the entries, "100% by promotion from amongst the posts of Assistant Auditor who are drawing pay in the Pay Matrix Level-6 ₹ 35,400-1,12,400 who have completed atleast 5(five) years of regular service in the Grade and having successfully completed minimum 2 to 4 weeks training in the subjects specified by the Department for the functional requirement, knowledge and skill upgradation of feeder Grade Officers and infrasructure of the organization "shall be substituted.

(vii) For the entries in Column 13, the entries, "Consultation with the Arunachal Pradesh Public Service Commission is not Applicable as per the Arunachal Pradesh Public Service Commission (Limitations of Functions) Regulation, 1988 as amended from time to time" shall be substituted.
