## NOTIFICATION

### The Arunachal Pradesh District Mineral Foundation (Trust), Amendment Rules, 2023

No. DGM-11025/2/2021. — In exercise of the powers conferred by Section 9 B, Sub-Section (4) of Section 15 A read with Section 21 of the Mines and Minerals (Development and Regulation) Act, 1957, the Governor of Arunachal Pradesh hereby makes the following rules further to amend **The Arunachal Pradesh District Mineral Foundation (Trust), Rules, 2018**, namely : —

1. (1) These rules may be called “**The Arunachal Pradesh District Mineral Foundation (Trust), Amendment Rules, 2023**”.
- (2) They shall be deemed to have come into force on the date of its publication in the official Gazette.
2. In **The Arunachal Pradesh District Mineral Foundation (Trust), Rules, 2018**, (hereinafter, the principal rules), in rule 6 (i) for the composition of the District Mineral Foundation, the following shall be substituted : -

	(i) HMP of Lok Sabha of the concerned District.	
	(a) In case, there are more than one MPs of Lok Sabha in a district, all MPs of Lok Sabha of the districts shall be members of the Governing Council.	
	(b) In case, the constituency of one MP of Lok Sabha falls in more than one districts the MP of Lok Sabha shall be member of the Governing Council of all such districts).	
	(ii) HMP of Rajya Sabha of the concerned District.	
	(a) MP of Rajya Sabha from a state shall be a member of the Governing Council of one district selected by him/her.	
	(b) The Rajya Sabha MP shall intimate name of the district selected by him/her to the Secretary in-charge of the Mining Department of the state who in turn shall inform the concerned District Magistrate/Deputy Commissioner.	
3.	HMLAs of the concerned district	: Members
4.	Zila Parishad Chairperson	: Member
5.	AMDO or officer from the Department of Geology & Mining posted at District Headquarter	: Member Secretary
6.	All AMDOs posted in the district	: Member
7.	Project Director, District Rural Development Agency	: Member

3. (i) In the Principal Rule, in **rule 8 (A) (i) & (B) (1)** for the words “**prospecting license-cum-mining lease**”, the words “**composite license**” shall be substituted.
- (ii) In the Principal Rule, in Rule 8 (B) (2) after the words “**Every holder of Mining Lease**”, the words “**and prospecting licence-cum-mining lease or composite license**” shall be inserted.
