## PRELIMINARY NOTIFICATION

The 13th October, 2025

(Issued under Section 11 (1) of the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011(14)/10/2025.— **WHEREAS**, the Power and Function of the appropriate authority under the Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercises and discharged by him within the State.

WHEREAS, the office of the Power Grid, Daporijo, has sent a requisition vide letter No. NER/ APCOMP/Daporijo/501/812 dated 24th May, 2025 for acquisition of land to and extent of 982 Sqmtr for the Construction of Approach Road towards proposed 33/11 KV Muri-Mugli Sub-Station at Muri-Mugli Village under Comprehensive Scheme for Strengthening of T&D in Arunachal Pradesh under Puchigeko Circle of Kamle District, Arunachal Pradesh.

**NOW THEREFORE**, this notification is made under the provisions of Section-11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey and land to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section -11(4) of the Act, no person shall make any transaction or cause any transaction of the Land i.e. Sale/Purchase/Gift, specified in the preliminary notification or creates any encumbrances on such land from the date of publication of this notification without prior approval of the collector.

Any person interest in the said land and whomsoever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, Kamle District Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office
