DECLARATION

The 13th October, 2025

(Under Section-19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No.LMD-13011(11)/12/2025/1671.—**WHEREAS**, it appears to the Governor of Arunachal Pradesh that a total area of **6.30 Hectares (63000 Sq.mtrs)** of land is required at **Jairampur-Longvi area under Jairampur Sub-Division** of Changlang District, Arunachal Pradesh for public purposes, namely for **"Construction of Jairampur-Longvi Road ( 0.000 KM to 3.500 KM) "** by the 103-RCC(GREF), C/o 99 APO, Border Roads Organization.

**AND WHEREAS**, a preliminary notification as required under Section 11 Read with Section 40(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued by the Department of Land Management vide Memo No. LMD- 13011(11)/12/2025 dated Itanagar, the 3rd July, 2025 notifying the intention of the State Government for acquiring of 6.30 Hectares (63000 Sq.mtrs) of the said land and inviting public claims and objections to the proposed acquisition of land any.

**AND WHEREAS**, the Deputy Commissioner, Changlang District, vide his Memo No. C/LR/103-RCC(GREF)/ 25/NV dated Changlang the 29th August, 2025 certified that land is private land (except RF area and any other Government land) and free from public and Government projects and that there are no project affected families and therefore no compensation towards Rehabilitation and Resettlement are required to be paid under Section 31 of the LARR Act and has requested the State Government to issue the draft declaration under Section 19 of the LARR Act, 2013.

**AND WHEREAS**, the Appropriate Government is pleased to note that it is satisfied that Chapters-II and III and Section-15 and 16 shall not apply to acquisition process in respect of the said land at Jairampur-Longvi area under Jairampur Sub-Division of Changlang District, Arunachal Pradesh for public purposes, namely for "Construction of Jairampur-Longvi Road ( 0.000 KM to 3.500 KM)" by the 103-RCC(GREF), C/o 99 APO, Corder Roads Organization.

**AND NOW**, therefore the Governor of Arunachal Pradesh is pleased to issue the Declaration under Section 19 of the Act specifying that the piece of land measuring 6.30 Hectares (63000 Sq.mtrs) at Jairampur-Longvi area under Jairampur Sub-Division of Changlang District, Arunachal Pradesh for public purposes, namely for "Construction of Jairampur-Longvi Road (0.000 KM to 3.500 KM) " by the 103-RCC(GREF), C/o 99 APO, Corder Roads Organization is being acquired.
