#### NOTIFICATION

The 21st April, 2025

No. AR/219/2022-US-1-AR/234.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to relax the prescribed upper age limit for direct recruitment issued vide Notification No. AR/219/2022-US-1-AR dated 25th February, 2023 and to grant **ONE TIME RELAXATION** on upper age limit for direct recruitment to all General Category Candidates, born on or after 1st January, 1989 and the Arunachal Pradesh Scheduled Tribe (APST) candidate born on or after 1st January, 1984 enabling them to be eligible and to apply for those categories of posts where the previous vacancy notifications (issued prior to 2024, details of the notifications are placed at Annexure-I) has been/will be cancelled by the Arunachal Pradesh Public Service Commission (APPSC), subject to following conditions:

- (i) The previous vacancy notification, mentioned in the Annexure-I, has been/will be cancelled within a period of 6 (six) months from the date of issue of this notification.
- (ii) The fresh vacancy notification is issued by the APPSC within a period of one year from the date of issuance of this notification. However, the number of the vacancies may vary from the cancelled notification.
- (iii) The applicant shall be otherwise eligible as per the recruitment rules of the particular category of posts.

This notification of One Time Age Relaxation will expire on completion of one from the date of Notification. (By order and in name of the Governor of Arunachal Pradesh).
