NOTIFICATION

The 22nd October, 2025

(Under Section 10 of the Balipara/Tirap/Sadiya Frontier Tract Jhum Land regulation (Amendment) Act, 2024)

No.LMD-13011/35/2025/1724.—**WHEREAS**, the powers and functions of the appropriate authority under Section 10 of Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amendment) Act, 2024 is vested in the Governor of Arunachal Pradesh and it is the competence of the Government to notify any land within the State of Arunachal Pradesh for public purposes under the relevant Act, Rules etc.

AND WHEREAS, the Governor of Arunachal Pradesh is satisfied that the land mentioned in the schedule below is needed for a public purpose, namely, for construction of approach road for 33/11 KV Koyu Sub-Station under Comprehensive Scheme for Strengthening of Transmission and Distribution System in Arunachal Pradesh in Lower Siang District, Arunachal Pradesh.

AND WHEREAS, under Section 10 of Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amendment) Act, 2024, Government may acquire any Jhum Land required for public purpose without formal acquisition proceedings by giving an opportunity to those having rights in the land and after payment of a reasonable compensation so determined by the Government which shall not be less than the amount computed under the provisions of extant Law i.e, the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for the time being in force.

NOW, THEREFORE, the Governor of Arunachal Pradesh do hereby declare that the land described in the schedule below is hereby notified for the above mentioned purpose under Section 10 of the Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation (Amendment) Act, 2024 for the construction of approach road for 33/11 KV Koyu Sub-Station under Comprehensive Scheme for Strengthening of Transmission and Distribution System in Arunachal Pradesh in Lower Siang District, Arunachal Pradesh.

Any person (s) who has any objection to the acquisition of the said land for the said purpose may file such objections in writing to the office of the Deputy Commissioner, Lower Siang District within a period of 30 (thirty) days from the date of publication of this notification clearly stating the reason for such objections and the Deputy Commissioner, in their capacity shall dispose off the same after giving reasonable opportunity of being heard to extinguish the claim of the land owners.

The Deputy Commissioner, Lower Siang District shall take possession of the abovementioned land for the said purpose after tendering payment of compensation to the land owners/ person interested.

The map and plan may be inspected in the office of the District Land Revenue and Settlement Officer, Lower Siang District, Likabali during office hours.
