PRELIMINARY NOTIFICATION

The 21st October, 2025

(Issued Under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LMD-13011/29/2025/1715.—**WHEREAS**, the power and function of the appropriate authority under the Right to Fair Compensation and Transparency in LARR Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the State.

WHEREAS, the requiring body 125 RCC (BRTF) has sent a requisition vide No. Nil dated 11th September, 2024 for acquisition of land to an extent of 96000.00 Sqm for construction of Chakseng GG-PT 4594 Road in Rho and Jangda Villages under Lhou and Thingbu Circle in Tawang District.

WHEREAS, it appears to the Governor of Arunachal Pradesh that land is likely to be needed at the locality more fully described in the schedule below for Chakseng GG-PT 4594 Road in Rho and Jangda Villages under Lhou and Thingbu Circle for an area measuring 96000.00 Sqm for Road in Rho and Jangda Villages under Lhou and Thingbu Circle in Tawang District. It is hereby notified that land in the locality/localities in the schedule below is likely to be acquired for the above said purpose at expenses of requiring body. Further, the Deputy Commissioner, Tawang District, Tawang vide his letter No. TLR-70/2013-14 dated 30th July, 2025 has informed that there is no habitations nearby, therefore there will be no adverse social impact as a result of acquisition of these lands by BRTF and also the number of families likely to be resettled due to the proposed land acquisition is nil and as such publication of summary of the Rehabilitation and Resettlement scheme is not required.

NOW THEREFORE, this notification is made under the provisions of Section 11(1) of LARR Act, 2013 and to all whom it so ever may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engage for the said purpose with their servant and workman to enter upon and survey any land and to do all other acts in pursuance of the provision of Section 12 of the above said Act.

Under Section 11(1) of the Act, no person shall make any transaction or cause any transaction of land i.e. sale/purchase/gift, specified in the preliminary notification or create any encumbrances on such land from the date of publication of this notification without prior approval of the collector.

Any person interest in the said land and whosever has any objection to the acquisition of the said land, may within 30 (thirty) days from the date of publication of this notification provided under Section-15 of the Act, file such objection in writing before the Deputy Commissioner, Tawang District, Arunachal Pradesh.

The plan of the land may be inspected at the Land Management Branch, DC's Office, Tawang.
