No. HOME-11016/2/2024/10072.— In exercise of the powers conferred by sub-section (1) and (2) of Section 9 of the Manoeuvres, Field Firing and Artillery Practice Act, 1938 (Act No. 5 of 1938), the **Governor of Arunachal Pradesh** is pleased to **notify** the area described in the Schedule below within which **field firing and artillery practice of Rocket, Artillery and Howitzer weapon systems** shall be carried out **between November, 2025 and March, 2026** by the Indian Army.
